

Features New to This PSAP Edition

New with the PSAP-VI edition are the following:

- All testing is done online.
- Answers for each test module are supplied as portable document format (PDF) files.
- Chapters are shorter and more concise.
- Annotated bibliographies are expanded.

PSAP subscribers now submit all tests through ACCP's online education center.

Although subscribers can choose to receive books in either the print or online versions, test answers are available only in the electronic format. Based on subscriber feedback, PSAP chapters are shorter and designed to concentrate on information released in the past 3 to 5 years. Also, the number of annotated bibliographic references has been expanded because subscribers indicated that this documentation is valuable in their practices.

Continuing Pharmacy Education Credit



The American College of Clinical Pharmacy is accredited by the Accreditation Council for Pharmacy Education (ACPE) as a provider of continuing pharmacy education. Continuing pharmacy education credit for each PSAP-VI book is available for 3 years from the date of its release.

To receive ACPE continuing pharmacy education credit for a PSAP-VI module, a post test must be submitted online for scoring. Continuing pharmacy education credit will be awarded for test scores of 50% and greater. The answers to each continuing education post test are made available in electronic format to participants after they complete the test. After submitting a PSAP-VI post test, re-enter the online education center and click on the test you submitted. You will see your test with correct and incorrect answers identified. By completing the waiver form for any module, you waive the opportunity to receive continuing education credit for that module. After you submit a waiver for a post test, re-enter the online education center and click on that test. You will be redirected to a PDF file with answers for the module that you waived. Waiver statements are processed and mailed within 10 business days of receipt. The exception to this 10-day processing is the 3-month period after a book is released. Waiver statements will be mailed out after the BCPS tests are processed.

BCPS Recertification

Subscribers submitting a PSAP-VI post test for BCPS recertification credit have a narrow window of opportunity (the 3-month period before the release of the answer book) to use each module for recertification. The due date to submit online tests for BCPS continuing education credit is listed on the opening page of each print and online book.

Tests submitted for BCPS recertification credit will be processed and results mailed within 60 days of the published due date. Only completed tests are eligible for credit; no partial or incomplete tests will be processed. The passing point for BCPS recertification is based on a statistical analysis of the examination scores received for each module. If you receive a passing score, that information will be forwarded to BPS, and a statement of continuing pharmacy education/BCPS recertification credit will be sent to you.







ACCP will launch the seventh edition of the popular *Pharmacotherapy Self-Assessment Program (PSAP-VII)* in January 2010

Cardiology will be the first book in the new 11-book series, followed by Urgent Care/Critical Care; Women's and Men's Health; Pediatrics; Chronic Illness; Oncology; Geriatrics; Science and Practice of Pharmacotherapy; Infectious Diseases; Neurology/Psychiatry; and Gastroenterology/Nutrition.

New features for PSAP-VII include the integration within each book of content such as health promotion and maintenance, statistics, and literature evaluation. Relating this complementary material to traditional clinical topics provides a more practice-based view of the content. Pediatrics and Geriatrics also return as separate books in the PSAP-VII series.

As with the previous edition, PSAP-VII will feature shorter chapters, expanded annotated bibliographies, and online testing. Chapters focus on the latest information (the past 3–5 years) to allow pharmacists to develop and assess their knowledge and to enhance their educational competence. The second edition of ACCP's *Pharmacogenomics: Applications* to *Patient Care* is scheduled for publication in the summer of 2009. *Pharmacogenomics* is designed to provide a comprehensive discussion of key areas in genomics important to pharmacists and other health professionals by developing the participant's knowledge and skills needed to apply the concepts of genomics research to drug therapy decisions within health care organizations.



This book will document and comment on the development of clinical pharmacy as a profession transformed from product focused to patient focused. Using personal observations and commentaries from pharmacy leaders and others, it will reflect on the impact that significant events, publications, and trends have had on the development of pharmacy as a true health care profession employing pharmacists with specialized knowledge, experience, and judgment to optimize medication therapy and promote health, wellness, and disease prevention.

After examining the changes that have taken place during the past 40 years in pharmacy practice, education, and research, the book will culminate in recommendations and perspectives for the future.

ACCP Advocacy Agenda 2009

ACCP seeks to achieve targeted, strategic advocacy objectives through a combination of activities involving the professional staff, multi-organizational coalitions, and our individual members. The objectives are consistent with the College's strategic plan and the expressed and identified needs of the membership as articulated through the ACCP Board of Regents. These activities are directly primarily



at the federal level, although certain state and regional issues may also attract the involvement of the College. The priority issues for 2009 are:

Expanded Access to Pharmacists' Services under Medicare Part B

- Advocate for the introduction of legislation that would provide coverage of and payment for the direct patient care services of qualified pharmacists under Part B of the Medicare program and other major health insurance plans.
- Continue to play a lead coordinating role in the Leadership for Medication Management (LMM) coalition to achieve introduction of legislation in Congress that results in the inclusion of the direct patient care medication management services of qualified pharmacists under Part B of the Medicare program.
- Actively pursue legislative or regulatory strategies that may achieve comparable results as part of the process of Congressional evaluation, oversight, and possible legislative changes to the Medicare Part D outpatient drug benefit and its associated Medication Therapy Management (MTM) component.

Enhanced Patient Care under Medicare Part D

- Seek expanded, comprehensive Medication Therapy Management services (MTMS) under Medicare Part D.
- Work with the pharmacy community to increase communication and interaction with the Centers for Medicare and Medicaid Services (CMS) to promote more specific structure and enhanced evaluation of the MTMS component of the Medicare Part D outpatient drug benefit.

Improved Data Collection on the Value of Pharmacists' Services

- Support and advocate for increased utilization of Comparative Effectiveness research as a means to identify the most effective treatments and reduce health care costs.
- Work closely with Agency for health research and Quality (AHRQ) staff responsible for quality assessment of the Medicare Part D benefit, with particular attention to MTM programs, models of collaborative care, and performance-based practice models to encourage and facilitate the collection of data that supports better approaches to effective medication use.

Restore Medicare Funding for Second Year Residency Training

• Continue to seek restoration of Medicare funding for specialized residency training under Medicare prospective payment rules. In cooperation with ASHP and AACP government affairs staff, work with CMS to establish benchmarks and data supporting the value of and need for Medicare support for second-year and 2-year integrated residency training for pharmacists in facilities that are Medicare providers.

Promote Policies that Improve Medication Safety

- Monitor and influence as needed legislation and regulations dealing with issues of medication safety and rational medication use.
- Work with appropriate health associations and advocacy organizations to promote greater medication safety through more active involvement of pharmacists in patient care.

Support for Pharmacy Professional Education Programs

• Working with AACP, continue advocacy for passage of legislation and/or enhanced appropriations for existing programs to enhance support for the nation's pharmacy education infrastructure to help assure an appropriate supply of pharmacy professionals for their roles in clinical practice, education, and research.

Loan Repayment Programs for Pharmacy Graduates

- National Health Service Corps (NHSC): Seek pharmacist participation in NHSC loan repayment programs available through federally qualified health centers, as authorized by Senate language that permits the Health and Human Services (HHS) Secretary to include pharmacists in the program. Monitor House of Representatives NHSC reauthorization to seek clarification on pharmacist eligibility for the program.
- Title VII Funding: Support development of inter-professional health education programs. Work with Congress to make programs authorized under Title VII of the Public Health Service Act a significant aspect of comprehensive health professions education. Programs funded under Title VII are the only federal program focused on health professions education and provide essential support in addressing pharmacist workforce shortages, particularly in rural and underserved areas.

Increase the Prominence and Visibility of Clinical Pharmacists in Government Agencies and related advisory panels.

• Working collaboratively with other science-based pharmacy organizations and appropriate agencies of the federal government, identify and promote the inclusion of clinical pharmacists for participation on National Institutes of Health study sections, U. S. Food and Drug Administration advisory panels, and similar agency and related groups (e.g., United States Pharmacopeia) involved in both basic and clinical research in pharmacotherapy and related sciences.

Related Supporting Messages:

• Practice Model Change - Promote better understanding of Collaborative Drug Therapy Management (CDTM) as a more comprehensive model of care that better achieves the goals expected of MTM - broaden the distribution of ACCP's 2005 message to the Institute of Medicine (IOM) concerning the need for a *pharmacotherapist* as a integral member of the health care team.

- Payment Policy Change Encourage and promote dialogue and policy discussions seeking change from the traditional drug product-based reimbursement structure for pharmacy to payment for the provision of clinical services.
- Access to Care Work to ensure a patient-oriented structure of care. Expand the pool of beneficiaries eligible for MTMS. Encourage payers across all sectors to expand their provision of MTM/CDTM services to further encourage safe and appropriate medication use. (According to the IOM report, one-third of adults take five or more medications each week similar to the criteria required for MTMS under Part D)
- Program Costs Promote clinical pharmacists' services as a mechanism to help reduce the financial burden on Medicare, Medicaid, and State Children's Health insurance programs resulting from medication errors and adverse drug events. Also help ease the burden on employers and small businesses struggling with rising health care costs.

Future Trends

- FDA reform Encourage a balanced FDA approval process
 that will not needlessly prevent access to needed drugs in the
 marketplace but still ensures safety and encourages more aggressive
 and effective post marketing surveillance.
- Impending economic challenges of Medicare and Social Security spending (the "baby boom" problem) Work with other organizations seeking policy changes to promote the long-term viability of both programs.
- Work with allies and in coalitions to help create a climate in which the budgetary and appropriations processes recognize the importance of reducing costs and improving quality through continued investment in public health; healthcare research and information; and access to preventative care.
