<u>Practice Examinations Available</u> BPS has posted brief practice examinations on the BPS website at <u>https://www.bpsweb.org/practiceexam/</u>

The Board of Pharmacy Specialties' online practice tests are self-study guides. The objective of these practice tests is to assist pharmacists who are preparing to take the BPS Certification Examination. The practice tests are only one tool to be used in preparation for the certification exam and are not intended to be used as the sole preparation guide for the certification exams. A practice test should be used in conjunction with other study aids and practice experience.

2011 Exam Registration Closes on August 1, New Sites Added

Added Qualifications Criteria Clarified

In April, the BPS Board accepted the Pharmacotherapy Specialty Council's recommendations to modify the Added Qualifications criteria requiring applicants for Added Qualifications in Infectious Disease and Cardiology to have <u>at least two years experience after terminal training</u> to be eligible for Added Qualifications. Experience associated with a training program, such as a residency or fellowship, should NOT be included; only those experiences and publications occurring as an independent practitioner over the past 7 years will be considered as part of this application process. Ambulatory Care Pharmacy Designation

The official designation for pharmacists who pass the ambulatory care pharmacy specialty certification exam will be Board Certified Ambulatory Care Pharmacist and these pharmacists will carry the initials BCACP. This decision was reached during the April meeting of the BPS Board of Directors.

BPS Issues Call for Members of the Critical Care Pharmacy and Pediatric Pharmacy Practice Analysis Taskforces

During the BPS Board meeting held on April 9, 2011, the Board reviewed the preliminary request to consider two new specialties: Critical Care Pharmacy and Pediatric Pharmacy. BPS will move forward with conducting role delineation studies for each of these proposed specialties. Conducting a role delineation study is a critical step in evaluating a proposed specialty. The purpose of these role delineation studies is to determine whether Critical Care Pharmacy and Pediatric Pharmacy are based upon a specialized knowledge of the pharmaceutical sciences as well as specialized functions routinely performed by practitioners in these proposed specialties.

To begin moving forward with the role delineation studies in Critical Care Pharmacy and Pediatric Pharmacy, BPS will need the following:

 Names and resumes of subject matter experts in the areas of Critical Care Pharmacy and Pediatric Pharmacy; (8 to 10 individuals will be selected to serve on each Practice Analysis Task Force). However, in addition to these Task Forces, additional subject matter experts can assist BPS by participating in a telephone interview, an e-mail–based external review of documents developed by the relevant Task Force, or the pilot test of the related survey.
