Tips: Preparing for the Residency and Fellowship Forum

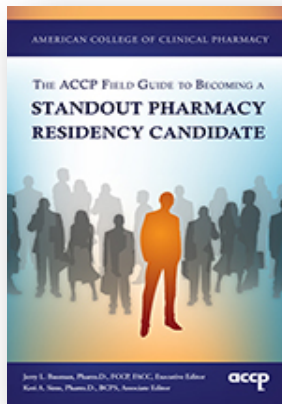
- **Post your Applicant Profile Online.** Providing your contact information will allow potential preceptors/program directors to contact you before and after the Annual Meeting. To post or update your applicant profile visit <http://www.accp.com/meetings/am12/applicantReg.aspx>.
- **View Available Positions Online.** The position listings will give you details about each position, such as the position type, application deadline, start date, salary and a detailed description of each position. To view posted position, visit <http://www.accp.com/careers/onlinePositionListings.aspx?forum=1>.
- **Determine your Target Programs.** Determine which program booths you would like to visit and use the diagram provided to know where each program will be located at the forum.
- **Prepare Questions Before the Forum.** Prepare your questions ahead of time. This will help you and the program representatives make the best of the limited time. If there is not enough time

to talk, ask the preceptors/program directors if they are available to talk with you at another time during the Annual Meeting.

- **Be Prepared to Answer Questions.** Although the forum is in an informal setting, be prepared to treat it like an interview. You must be prepared to answer any questions asked by the program representatives.
- **Follow-up.** A thank you note can help you leave a good lasting impression.

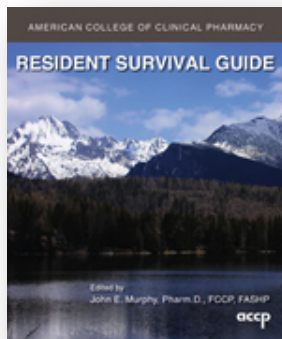

This program also includes shared longitudinal experiences with Butler Pharmacy Practice Faculty and their affiliated practice sites that include Primary Care, Family Medicine, and anticoagulation clinics throughout the Indianapolis area. This residency will develop the clinical knowledge and skills essential to public health that include: evidence base for practice, clinical preventative services/health promotion, community aspects of practice and population based approaches to health. In addition, experience in pharmacist based disease management programs are provided in the areas of weight, anticoagulation, lipid, hypertension, diabetes, and medication therapy management. Didactic and experiential teaching experiences and completion of a research project are required. Participation in the Indiana Pharmacy Teaching Certificate Program (IPTeC) is also required.

Post-doctoral Fellow Program Applications are now being accepted for the Congressional Pharmacy Healthcare Policy Fellow Program, an innovative collaboration of the School of Pharmacy at the Medical College of Virginia/Virginia Commonwealth University, the American College of Clinical Pharmacy (ACCP) and the American Society of Health-System Pharmacists (ASHP).

This year long Washington, D.C.-based program, which is described in detail at <http://www.pharmacy.vcu.edu/sub/prog/guidelines.aspx> provides an in-depth healthcare policy analysis and development experience in the United States Congress.

Fellows spend a month with each of the professional organizations as members of their respective government and professional affairs staff. In November of the fellow year they begin working in a legislative environment requiring healthcare input on the staff of an individual Senator or Representative or a relevant Congressional committee.

It is designed to help prepare individuals for a range of career areas, such as an academic career in health services/policy research, as a congressional staff member, as an agency congressional liaison, or as a government affairs staff member of a professional society or pharmaceutical company.

Stipend support will be \$57,000 for the one year experience as well as an allowance for moving expenses of up to \$1,000, an allowance for professional travel of \$1,500, and health insurance coverage provided through MCV/VCU School of Pharmacy.

Application guidelines are available on the program website and applications will be accepted until the position is filled. All letters of reference, along with the Candidate Statements and the Conflict of Interest Disclosure Statement, should be sent via email to the program director at the address listed below. The finalists will be interviewed in Washington, DC, and the successful candidate will be announced in late spring of 2013.

Frequently Asked Questions

I registered for this event hoping to learn more about residencies and fellowships - I'm not quite ready to apply for these yet (I still have two more years left of pharmacy school). Do I still need to submit an applicant profile if I am not ready to apply?

Yes. Submitting your applicant profile gives program directors an idea about who you are and where you are in your career. It also tells them what your intentions are i.e. whether you are looking for a particular position or if you are inquiring about their programs.

Is this event for current students?

Yes. Current students and residents who will be entering residency or fellowship programs in 2013 are encouraged to attend. All the positions posted begin in 2013. Students and residents who are not ready to apply are welcome to come and inquire about the residency or fellowship programs represented.

How do I prepare for the forum? What should I bring to the forum?

Determine which program tables you would like to visit and read the position requirements prior to the forum. Use the forum layout (to be e-mailed to you) to know where each program is located. You are encouraged to bring a printed resume, with your contact details, for the program representatives.

I am presenting a poster at the same time that the forum is occurring. What do I do?

The forum is open for two hours. If there is a particular program that you would like to visit, plan to come in at anytime during the two hours. If you are short on time, let the program representatives know that you are presenting a poster and ask if they are available to talk to you at another time during the Annual Meeting.

Is there a list of programs that I can access before the forum?

A detailed list of positions, programs and program representatives is available at the ACCP website at <http://www.accp.com/careers/onlinePositionListings.aspx?forum=1>. A printable list with the forum layout will be e-mailed to each candidate before the meeting. This layout will also be made available at the forum.

How long should I stay at each table?

Since there are usually over 200 students and residents waiting to talk to program directors, try to spend no more than 5 minutes at each table. If you run out of time, ask the program director if they are available to talk with you at another time during the Annual Meeting.
