### **The Soul of ACCP**

I was pumped after returning home from the ACCP Annual Meeting in October. Great souls had gathered to learn how to practice, teach, and conduct research with cultural proficiency; share their creative energies and intelligence during committee and task force meetings; network to improve patient, student, and pharmacist life; and rekindle personal and professional friendships. The Task Force on Advocacy began to develop training and motivational programs to help all of us become better grassroots advocates and to design ACCP's formal grassroots group—the ACCP Advocates. The wheels on the ACCP bus were moving fast and in the right direction. The journey would be exciting.

But one green bus stopped that following Friday. I flew back to Minnesota that afternoon to purge my old office, just hours after Minnesota Senator Paul Wellstone, some of his family and staff, and pilots died in a plane crash. People were stunned as “The Soul of the Senate”—as declared by other U.S. senators—passed away. Who would look out for the “little guy”? Could citizens from middle and lower incomes ever again obtain Congressional office? If the Democrats lost the Minnesota Senate race and control of the Senate, would we have a national government unbalanced to represent all citizens? During that week, I talked more about politics, freedom of speech, underused grassroots voices, and low voting turnouts than I ever had before. Conversations were refreshing, stimulating, and challenging. I developed a heightened citizen responsibility and commitment to my personal BHAG (big hairy audacious goal) for ACCP this year—all members would develop a partnership with a national legislator in this year of Very Important Partnerships.

Although I didn't agree with Senator Wellstone on all issues, I admired greatly his courage to speak, passion to challenge the status quo, frontier work in mental health and farm issues, compassion for life and liberty for all, commitment to family values, and yes even his liberalism. I realized that many of these traits are the same reasons I value and admire all the ACCP members! But do we really espouse our core values to extend frontiers, achieve excellence, and challenge the status quo, especially outside our work environments? Do legislators, policy-makers, and our patients see these core values?

I also miss the “Hippie” days when people spoke up en masse and even protested for civil rights, democracy, peace, etc. Have we become too comfortable with our salaries? Can we as ACCP members get back this zest for change and righteousness? We know health care is not universally available to all. We also know pharmacist services are not covered and available to all, even though we improve patient outcomes and quality of life and contribute to society by providing cost-effective care. But how many of us have told our stories to our legislators?

## President's Column (continued)

As ACCP president and (now) Michigan resident, I visited my new U.S. senators after a recent meeting of the Joint Commission on Pharmacy Practitioners in Washington, D.C. The Senate was in recess and most of the Senators were back home; however, I was able to talk to both Senator Carl Levin's and Debbie Stabenow's health legislative aides—the staff who do fact finding and help the senators develop their positions on health-related issues. My impression was that neither knew about pharmacists providing great patient care, achieving Healthy People 2010 goals, and saving valuable health care dollars. As an example, I explained how pharmacists in the community, clinics, and hospitals improve outcomes for patients with asthma (a medical condition with which they would be familiar from a patient and physician perspective, but not from a pharmacist perspective) and keep them out of the ER and hospital. I could see that the light bulb for pharmacist services was turned on. I also reviewed some of their written health-related information and suggested where mention of the pharmacist's role as medication therapy manager could be added, or where clearer or more accurate medication information could be used.

Although I had an unrealistic goal that my new senators would support pharmacist provider legislation that day, I did establish a dialog to pursue that outcome in the future. The voice of one can open the door, but as Kim Love, Senator Stabenow's health aide said, "I haven't heard this from other pharmacists, what do they think?" Every pharmacist needs to talk to her or his legislators. If everyone did, the legislators would not only get the concept but know they should vote for something that is so right and important to their constituents from both the patient and provider perspectives. Luckily, I didn't hear from Ms. Love that others were speaking against our role or value—yet.

The New Year has begun. Let us all make a conscious and serious commitment to partner with our legislators. Please call, write, or e-mail your Congressional representatives and discuss your role in patient care and the outcomes achieved. In February, the Pharmacist Provider Coalition expects legislation to be introduced in the next Congress to recognize pharmacists as Medicare providers, a first step to enabling payment for pharmacists' patient care services by Medicare. We need you to develop a relationship with your legislators NOW so that from February until bill passage, your Congressional representatives will know you and value your input. Remember that you not only have a story to share, but as a citizen and ACCP member you also have a responsibility to contribute to our democratic process.

Here's how simple and quick it is to begin a partnership with your legislator. 1) Find your senators and representative by going to the ACCP Legislative Action Center at <http://www.accp.com> and clicking on "Legislative Action". 2) Page down to "Elected Officials" and enter your home zip code. 3) Click on "E-Mail" and write a letter to your Senators or Representative. Tell them you appreciate their activities supporting quality health care for all. Tell a story about your practice/role in patient care and how you improve patients' quality of life and save health care dollars. Conclude with

a) you hope they will support future legislation that incorporates pharmacists as valuable health care team members as well as a prescription drug benefit for seniors that includes both prescriptions and the drug therapy management services of pharmacists; and then b) offer your expertise for future pharmacy and prescription drug legislation. Thank the legislator for the opportunity to share your thoughts. 4) Click Send. 5) Pat yourself on the back. You are now a VIP in ACCP's grassroots efforts. 6) Wait for the reply. 7) Repeat the activity in February when we launch the pharmacist provider legislation again. 8) Catch the advocacy bug. Once you've got it, you'll be energized by helping to create positive change and useful policies that help patients. Be gutsy, try it right now and see how quick, easy, and fun it is. You'll soon be a productive grassroots advocate.

I challenge you to get on the Soul of ACCP bus. The only requirement is to communicate with your legislator(s) now to begin a relationship. Our journey is challenging but will be more triumphant with you on board. Remember that not acting could significantly change your life if pharmacy services are not recognized appropriately within Medicare. So members, the Soul of ACCP, shout your message. Constituent voices sing the loudest in a legislator's office. Welcome aboard, the future is brighter because of you.
