Dager, Figg, McLeod, and Raasch to Receive ACCP Honors

ACCP members William Dager, Pharm.D.; Douglas Figg, Pharm.D., FCCP, BCPS; Howard McLeod, Pharm.D., FCCP; and Ralph Raasch, Pharm.D., FCCP, BCPS have been selected by the College's Awards Committee to receive the association's prestigious 2008 Clinical Practice, Russell R. Miller, Therapeutic Frontiers Lecturer, and Education Awards, respectively. The awards will be presented in Louisville on Sunday morning, October 19, during the Opening General Session of the College's 2008 Annual Meeting.

The ACCP Clinical Practice Award is given to a College member who has made substantial and outstanding contributions to clinical pharmacy practice. The criteria considered in identifying potential candidates include exceptional leadership in the development of innovative clinical pharmacy services and sustained excellence in providing these services. Willam Dager is a pharmacist specialist at the University of California, Davis Medical Center (UCDMC). He also holds an appointment as Clinical Professor of Pharmacy at the University of California, San Francisco (UCSF). Dr. Dager's outstanding accomplishments include more than 20 years of practice leadership in clinical pharmacy, including work that has been instrumental in justifying and developing clinical pharmacist service roles in critical care, clinical pharmacology consult services, and inpatient anticoagulation management. In particular, his contributions in the areas of cardiology and anticoagulation have assisted many ACCP members in the clinical management of their patients. In recommending Dr. Dager, one of his nominators wrote about his frequent contributions to ACCP's Adult Medicine and Cardiology Practice and Research Networks (PRNs). "He has provided the networks with insightful answers that reflect his research and clinical expertise. This has enabled me

to educate our staff in a more efficient and timely fashion. He is quick to offer valuable perspective and guidance on the therapeutic dilemmas and challenges posted on the listserves." Dr. Dager has received numerous awards, including the UCSF/UCDMC Outstanding Preceptor of the Year, Fellow of the California Society of Health System Pharmacists, the UCDMC Outstanding Achievement Award, and the UCSF Long Prise for Excellence in Teaching. His publication record includes numerous research articles, reviews, practice guidelines, and book chapters that focus on clinical pharmacy and pharmacotherapy.

The Russell R. Miller Award is presented in recognition of substantial contributions to the literature of clinical pharmacy, thereby advancing both clinical pharmacy practice and rational pharmacotherapy. Russell R. Miller was founding editor of the College's journal, Pharmacotherapy. Dr. Douglas Figg is Senior Scientist and Head of the Molecular Pharmacology Section, Medical Oncology Branch, Center for Cancer Research at the National Cancer Institute in the National Institutes of Health at Bethesda, Maryland. He also serves as Head of the Clinical Pharmacology Program and Head of the Biological Fluid Research Core for multiple NIH units. A leading authority on the treatment of cancer, he has made sustained contributions to this area of therapeutics with particular emphasis on the importance of angiogenesis to prostrate cancer and improving treatment outcomes for hormonal-refractory prostate cancer. His body of work includes more than 350 peer-reviewed publications, including research papers, reviews, book chapters, and editorials. One of Dr. Figg's nominators commented, "Dr. Figg's research efforts have focused on the development of novel anticancer agents, with emphasis on the translational development of angiogenesis inhibitors. His efforts in moving new agents into the clinic have been instrumental for the NCI, and the oncology community in general. He has led the clinical evaluation of numerous agents, including thalidomide. In the case of thalidomide, Dr. Figg's efforts are especially noteworthy, in that he has played a critical role in both the pre-clinical and clinical development of this agent." He has trained in his laboratory more than 30 postdoctoral fellows, seven Ph.D. students, and more than 100 residents, students, laboratory assistants, and visiting professors/scientists. His scholarly efforts have resulted in numerous national and international awards, including the 2005 American Society of Clinical Pharmacology and Therapeutics Leon I. Goldberg Young Investigator Award and the 2007 NIH Clinical Center Director's Award. Dr. Figg currently serves on the editorial boards of more than ten scientific journals.

The ACCP Therapeutic Frontiers Lecture Award recognizes an individual, including ACCP member and nonmember nominees, who has made outstanding contributions to pharmacotherapeutics in his or her field. Among the criteria for this award is the broad acknowledgment that the recipient is currently considered to be at the leading edge of research in the field. Howard McLeod is the Fred N. Eshelman Distinguished Professor of Pharmacy and Director of the Institute for Pharmacogenomic and Individualized Therapy at the University of North Carolina, Chapel Hill. He is internationally recognized for his many important contributions to the field of pharmacogenomics of cancer chemotherapy. Dr. McLeod is widely regarded as a leading clinical and translational investigator and has published extensively during his career. One of his nominating letters points to Dr. McLeod's broad impact on pharmacogenomics and therapeutics. "Although Dr. McLeod has focused in the areas of cancer chemotherapy, it has been remarkable to see the contributions that he has also made more broadly to cardiovascular disease, anticoagulation and, indeed, how he has helped define general principles of therapeutics.... He is one of the few principal investigators in the country to receive NIH funding for a center for pharmacogenetics research... and who has been able to successfully bring together scientists from multiple fields-biostatistics, internal medicine, oncology, molecular biology, genomics-to facilitate interactions, collaborations, and make true progress in the field of pharmacogenomics." Dr. McLeod's lecture, titled "The Genome as a Tool for Clinical Pharmacy," will be delivered at 10:30 a.m. during Sunday morning's Opening General Session.

The Education Award recognizes an ACCP member who has made substantial and outstanding contributions to clinical pharmacy education at either the undergraduate or postgraduate level. Ralph Raasch is Associate Professor of Pharmacy in the School of Pharmacy at the University of North Carolina, Chapel Hill. Having served as a faculty member for 30 years, Dr. Raasch has distinguished himself as an outstanding teacher/mentor and as an exceptional practitioner-educator role model. Letters written by colleagues in support of Dr. Raasch's nomination speak to role as an exceptional educator and faculty member. One of his nominators wrote, "He has had major programmatic responsibility at the professional doctoral level since 1981 and served for many years as a member of the school of pharmacy's Curriculum and Progressions Committee." A colleague adds, "His lectures are interactive, case-based, and non-rehearsed exciting exchanges of information between he and his students.... He has been voted Teacher of the Year multiple times at the UNC School of Pharmacy and his unique style is legendary!" An accomplished and experienced infectious diseases clinician. Dr. Raasch is a fixture on the UNC infectious diseases consult service, where he precepts two students per month throughout the year. "Students really enjoy the ID consult service because Dr. Raasch has developed a role for both himself and the students. He is the co-leader of the consult service with an attending physician. The students learn clinical microbiology, virology, parasitology, and clinical immunology alongside medical students, residents and fellows." Also devoted to scholarship, Dr. Raasch has authored more than 50 peer-reviewed articles, more than 15 book chapters, and numerous pharmacotherapeutic reviews. He is a past ACCP Regent, a board certified pharmacotherapy specialist, and a Fellow of the College.


The flash drive will be attached to an attractive wristband bearing the "Go Forward" motto and the ACCP logo, making it a convenient option when you need an easy way to transport data.

ACCP Research Institute Announces Nationwide Practice-Based Research Network (PBRN) Initiative

In response to member feedback and input, as well as to the work of the 2008 Research Affairs Committee, the ACCP Board of Regents and the Research Institute Board of Trustees have enthusiastically and unanimously approved the creation of a nationwide ACCP PBRN.

A PBRN is a group of clinicians or practice sites that collaborate to answer questions related to their mission and purpose. As a funding agency for primary care PBRNs, the Agency for Healthcare Research and Quality (AHRQ) has set forth guidelines for PBRNs seeking grant support through its agency. AHRQ recognizes a primary care PBRN organizational structure only if it includes a core of at least 15 practices and/or 15 clinicians devoted to the primary care of patients. (Many PBRNs have started with fewer practices and/or clinicians, but they were not eligible for recognition

by AHRQ as primary care PBRNs.) Among the other requirements for forming an AHRQ-recognized PBRN:

- **Purpose and Mission Statement.** Each network has an accepted statement of its purpose and a mission that includes an ongoing commitment to the research endeavor.
- **Staff.** At a minimum, each network should have a network director and at least one dedicated staff member. The director is typically responsible for most administrative, financial, and planning functions for the network.
- Mechanism for Community Feedback. A mechanism should be in place for obtaining advice and feedback from the patient communities served by the network.
- **Communication Structure.** Each PBRN should have an organizational structure that transcends a single study, including multiple systems of communication with and among participating practices in the form of regularly produced newsletters, e-mails or listserves, conference calls, and/or face-to-face meetings of various combinations of network members.

Steps have been taken to address several of the above items, including the creation of mission, vision, and purpose statements. These statements were drafted by the 2008 ACCP Research Affairs Committee and adopted by both the

Research Institute Board of Trustees and ACCP Board of Regents.

Mission Statement. The mission of the ACCP PBRN is to facilitate collaborative research that promotes the safe, efficacious, and cost-effective use and delivery of medications and clinical pharmacy services.

Vision. The ACCP PBRN will be recognized as one of the premier practice-based research networks (PBRNs) in the nation within our defined research focus. Furthermore, the ACCP PBRN research focus will align with the College's strategic plan. The ACCP PBRN will be recognized as the premier facilitator of clinical pharmacy PBRN research. This will include promoting collaborative efforts between other pharmacy organizations and other national and local PBRNs.

Purpose. "In conjunction with stakeholders, the ACCP PBRN will work to advance the long-range strategic imperatives and mission of ACCP and the Research Institutes. This will, in turn, enhance the visibility and recognition of clinical pharmacists as vital practitioners and researchers.

Next Steps

The goals for the remainder of 2008 are to hire a parttime PBRN director, create a network listserve, and begin registering individual practitioners and affiliate PBRNs. The target year for completing the creation of a national clinical

Call for Abstracts: 2009 International Congress on Clinical Pharmacy

All investigators in the field of clinical pharmacy and therapeutics, both ACCP/ESCP members and nonmembers, are invited to submit abstracts to be considered for poster presentation at the 2009 ACCP/ESCP International Congress on Clinical Pharmacy. Abstracts may be submitted in one of the following categories:

Original Research: Abstracts must describe original research in education, health sciences, therapeutics, pharmacokinetics, pharmacodynamics, pharmacoeconomics, pharmacoepidemiology, or pharmacogenomics. Encore submissions are welcome.

Clinical Pharmacy Forum: Abstracts must describe the delivery, development, justification, or documentation of innovative clinical pharmacy services. Abstracts dealing with clinical services payment or cost analysis are encouraged. Encore submissions are welcome.

Resident and Fellow Research-in-Progress:

Submission and evaluation criteria are those of an Original Research presentation except that the research effort is ongoing. The presenting author must be a resident or fellow.

Student Submissions: Submission criteria are those of an Original Research presentation. Partially completed data are acceptable for inclusion. Abstracts should

provide an assessment of the likelihood of project completion by date of presentation. The presenting author must be a student.

Pediatric Research and Practice Abstracts: In conjunction with the Pediatric Pharmacy Advocacy Group, ACCP is accepting two categories of abstracts in pediatric pharmacy practice and pharmacology. 1) Pediatric Pharmacy Scientific/Research Abstracts presented at ACCP-PPAG report the results of a scientific investigation or a clinical observation involving some aspect of pharmacotherapy. Scientific investigations can be clinical, basic, or translational and should be either hypothesis-driven or descriptive. 2) Pediatric Pharmacy **Practice Abstracts** typically describe programs, systems, or projects that are innovative, creative, and cost-effective and that improve practice in pediatric pharmacy. Scientific presentations, case reports, research-in-progress, and encore presentations will be accepted.

Submission Deadline

All abstracts accepted for presentation (with the exception of Encore presentations) in the Original Research and Clinical Pharmacy Forum categories will automatically be entered in the Best Poster Award competition. Judging of finalists will occur during the poster sessions at the meeting. The deadline to submit abstracts is Saturday, November 1, 2008, midnight, Pacific Standard Time. Authors will be notified by e-mail of acceptance of their papers by November 30, 2008.

The listserve will feature updates from the ACCP Research Institute as we prepare to launch the new PBRN.

ACCP members are also invited to fill out the online registry tool. Although registration does not guarantee that your site will be selected as a research site, the Research Institute is seeking to build a pool of clinicians and sites interested in working on PBRN issues. President's Column

Core Values That Guide Our Mission



My presidential theme for this year, Fulfilling the Promise: **Excellence with Compassion,** encompasses several of the core values of the College (i.e., passion for extending the frontiers of clinical pharmacy and dedication to excellence in patient care). The theme is also embodied in the first critical issue of the College's strategic plan, which is to establish clinical pharmacy as an essential component of health care in all practice settings.¹ To *fulfill the promise*, the College's mission to promote innovative science and develop successful models of practice must be achieved. To actualize the mission, address critical issue no. 1 of the strategic plan, and become an essential member of the health care team, the College has embarked on several initiatives, including becoming one of the founding members of the Leadership in Medication Therapy Management coalition (see the Washington Report, page 3 of the June ACCP Report, at http://accp.com/docs/report/0608.pdf). Advocating for change in the health care system to include pharmacists as providers is an important step in the process of transforming health care delivery. However, recognition of the value of pharmacists at the technical or functional level of cognition may not be enough to stimulate the type and degree of changes in practice that will ultimately be needed. As in many situations, it is only when one engages another at an emotional level that the contribution is truly valued, whether the contribution is a product or service.

Given the foregoing, it is reasonable to ask if the mission of ACCP is relevant today and for the future. I think the answer to this question is an emphatic yes. The key, from my perspective, is that the College must reach out and connect with other health care professionals and society rather than shout to them from the other side of the chasm. In its infancy,

- Courage to lead while remaining responsive to the needs of members.

ACCP was regarded as a collection of "mavericks" who were dreaming dangerously, albeit in a precise, calculating way. Perhaps we are at such a time again (i.e., when we must first boldly envision the future needs of society, and then consider the profession). After all, who is it that we really serve? As an organization, we must ensure our relevance to those in need, our true constituency. We must avoid the temptation of becoming preoccupied with ourselves, filling our meetings with outstanding "performances" and writing to each other in our journals. The challenge, which is encompassed in the College's mission, is to motivate and enable ACCP members to become effective change agents who develop successful models of practice that enhance access to high quality patient care while maximizing the return on the investment in both cognitive and product-oriented pharmacy services. Our members build bridges across the gulf that currently separates most of the pharmacy community from other members of the health care team and the patients who need us.

Mission of the American College of Clinical Pharmacy

The American College of Clinical Pharmacy's purpose is to advance human health by extending the frontiers of clinical pharmacy.

Through strategic initiatives, partnerships, collaborations, and alliances, ACCP:

- Provides leadership, professional development, advocacy, and resources that enable clinical pharmacists to achieve excellence in practice, research, and education.
- Advances clinical pharmacy and pharmacotherapy through support and promotion of research, training, and education.
- Promotes innovative science, develops successful models of practice, and disseminates new knowledge to advance pharmacotherapy and patient care.

Many, if not all, members of the College believe not only that clinical pharmacists have the potential to change people's lives for the better but that there is credible evidence to support this assertion. Although some would argue that additional and better controlled evidence is needed, I believe the real issue is that we have not moved beyond the "model building" stage into the "franchise" phase. It is only when we reach that phase, in which transformed clinical pharmacy practices are available for people to "experience" anywhere in the country, that our contribution to the health of our community will be valued by society. Unfortunately, whereas society waits to see "IT" (i.e., a transformation of pharmacy practice in local neighborhood pharmacies from a productorientation to a patient-focused care orientation), the College and the profession are consumed with talking about "IT" among ourselves. We must move beyond mere possibilities and reach the point where enough people EXPERIENCE "IT" and thereby value "IT" that patient focused-care becomes a reality for all.

Therefore, the challenge before each member of this "member-driven" organization is to become an irresistible influencer and bridge-building advocate for patientfocused care.² This "IT" we are championing must become our defining point so that the mention of "IT" evokes an emotionally engaged response. "IT" must spark the imagination within each of us to envision how much better those in our community and around the world would be if patient-focused care were a standard component of health care. The thought of "IT" must inspire sacrifice, be built on faith that "IT" cannot fail, and encourage everyone to persevere until the gulfs that separate us from our team members and patients have been bridged.

This task is not for an internally focused organization or a profession that seeks self-preservation and winning turf wars. It is likely that if this status quo is maintained into the future, we will never see the promise of excellence with compassion that can result from "IT." The characteristics of those who will provide "IT" are articulated in the College's core values and the expectations of what the practitioners of "IT" will do are clearly defined in the ACCP and JCPP visions for future pharmacy practice.^{1,3}

During this decade, we have made progress. We have a profession-wide endorsed consensus document (the JCPP 2015 Vision of Pharmacy Practice³) that describes what our contribution to the transformation of health care will require of us. The map/plan of how to reach "IT" has been prepared. So, what are our next steps? I believe that we must, and can, collectively strive to build bridges within our communities and across the gulfs to ensure that the "Promise of IT"— excellence in patient care, research and education—is available throughout the United States. However, the vision does not stop (and dare I say *must not stop*) at our borders. As healing professionals, we should, out of compassion for humankind, seek to ensure that the promise of "IT" is available to all people, regardless of economic status, race, or residence in the world. Only then can we anticipate hearing

those comforting words as our lives draw to a close, "Well done, good and faithful servant!" (Matthew 25:23).

2009 ACCP Fellows: Fellowship is awarded in recognition of continued excellence in clinical pharmacy practice or research. Nominees must have been Full Members of ACCP for at least 5 years, must have been in practice for at least 10 years since receipt of their highest professional pharmacy degree, and must have made a sustained contribution to ACCP through activities such as presentation at College meetings; service to ACCP committees, PRNs, chapters, or publications; or election as an officer. Candidates may be nominated by any two Full Members other than the nominee or by any Fellow. Current members of the Board of Regents and the Credentials: FCCP Committee are ineligible for consideration. Nomination deadline: February 15, 2009.

2010 Officers and Regents: President-Elect, Regents, and Research Institute Trustees. Nominees must be Full Members of ACCP and should have (1) achieved excellence in clinical pharmacy practice, research, or education; (2) demonstrated leadership capabilities; and (3) made prior contributions to ACCP. 2009 Russell R. Miller Award: Recognizes an ACCP member who has made substantial contributions to the literature of clinical pharmacy, either in the form of a single, especially noteworthy contribution or sustained contributions over time. All nominations must include a letter of nomination detailing the nominee's qualifications for the award, the nominee's curriculum vitae, and two letters of support that describe the individual's accomplishments relative to the award criteria. At least one

of the letters of support must be from an individual outside the nominee's current place of employment. Additional letters of support also may be included. Current members of the Board of Regents, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: November 30, 2008.**

2010 Therapeutic Frontiers Lecture: Honors an internationally recognized scientist whose research is actively advancing the frontiers of pharmacotherapy. Recipients need not be ACCP members. All nominations must include a letter of nomination detailing the nominee's qualifications for the award, the nominee's curriculum vitae, and two letters of support that describe the individual's accomplishments relative to the award criteria. At least one of the letters of support must be from an individual outside the nominee's current place of employment. Additional letters of support also may be included. Robert M. Last fall marked the debut of ACCP's innovative Online Curriculum Vitae Review Program. The program is an exclusive service offered to student members as a means to facilitate their curriculum vitae preparation. ACCP is pleased to offer once again this important benefit to its student members.

As the clinical pharmacy profession continues to see an increase in demand for residency positions and competition for first-rate jobs, it is vital that students have a well-prepared curriculum vitae (CV). A well-written CV can provide a positive image for future selection committees or employers, and it distinguishes an individual from the rest of the crowd. As questions arise in preparing and completing one's CV, wouldn't it be helpful to have a seasoned professional review it?


