

## **2025 ACCP Annual Meeting Frequently Asked Questions**

### **What are the deadlines for abstract submission?**

June 15, 2025: Abstract submission deadline for all abstract categories, except Research-in-Progress.

August 15, 2025: Abstract submission deadline for Research-in-Progress abstracts (Students and Residents and Fellows, only)

### **What are the notification dates for accept/decline decisions?**

August 15, 2025: Notification of acceptance or declination of abstracts for all abstract categories, except Research-in-Progress no later than this date.

September 1, 2025: Notification of acceptance or declination of abstracts for Research-in-Progress (Students, Residents and Fellows, only) no later than this date.

### **Do I have to be an ACCP member to submit an abstract to the 2025 ACCP Annual Meeting?**

No. All investigators in the field of clinical pharmacy and clinical pharmacology are welcome to submit abstracts.

### **Do I have to be registered for the meeting to present my poster?**

Yes. All poster presenters must be registered for the meeting to present their poster. Presenters must either be registered for the full meeting or have a one-day registration for the day of their presentation.

Poster presenters *do not* qualify for guest registration. The guest registration is reserved for non-pharmacists, non-health professionals, and/or non-researchers attending the Annual Meeting. This registration category was established primarily to accommodate family/significant others who might wish to attend a spouse's/family member's/friend's presentation or a social event during the meeting.

### **Question 5: Does ACCP offer travel stipends or complimentary registration to poster presenters?**

ACCP offers travel stipends and/or complimentary meeting registrations to help defray the costs students, residents and/or fellows incur when traveling to attend an ACCP national meeting. Student Travel Awards and Resident/Fellow are administered through the ACCP Foundation and are funded by the Student Travel Award Fund and Resident/Fellow Travel Award Fund, respectively.

### **How many characters can be included in my abstract?**

All abstract categories have a 300 word-count limit, including tables. This abstract word limit does not include the abstract title, author names/affiliations or ACCP required headers. Encore abstracts are *excluded* from this word-count limit.

### **May I include a table, graph, or image in my abstract?**

Tables may be included in the abstract. Figures and images are not permitted within abstracts, with the exception of Encore abstracts. (Encore authors, please email Shelly Enders ([senders@accp.com](mailto:senders@accp.com)) if you have a figure within your abstract.)

### **Do I have to enter my abstract in a specific format?**

All abstracts, except for Encore abstracts, must conform to a structured format, and include ACCP-required headings. The required headings differ based on submission category. See the general instructions section for each abstract category for the required headings.

### **Can I revise my abstract after it has been submitted?**

You can revise/edit your abstract until the submission deadline. After the deadline, abstracts cannot be revised/edited.

### **If I would like to withdraw my abstract, what should I do?**

To withdraw your abstract prior to the abstract deadline, go to <https://www.accp.com/abstracts/index.aspx?mc=25AM>, log into your ACCP account and withdraw your abstract. After the abstract deadline, email Shelly Enders at [senders@accp.com](mailto:senders@accp.com) to have your abstract withdrawn.

### **When and how will I receive notification about the status of my abstract in the program?**

Presenting authors will receive email notification of acceptance or declination.

August 15, 2025: Notification of acceptance or declination of abstracts for all abstract categories, except Research-in-Progress no later than this date.

September 1, 2025: Notification of acceptance or declination of abstracts for Research-in-Progress (Students, Residents, or Fellows) no later than this date.

**May I submit my abstract to the 2025 ACCP Annual Meeting if it was previously presented as Research-in-Progress at another meeting?**

Yes, work presented previously as research-in-progress may be presented as a *new* abstract when the research has been completed.

In addition, a previously presented abstract may form the basis for a *new* abstract to be submitted (i.e., not an Encore presentation) for consideration in the Original Research category if the previous abstract:

1. was a descriptive report of planned research only,
2. described preliminary results only and complete results are now available (i.e. Research-in-Progress),
3. was presented at a student, resident, or fellow conference focused on gaining presentation experience and/or formative feedback,
4. was presented at an ACCP Chapter or PRN event, or
5. conclusions have been added/modified based on a new hypothesis and data analysis of the original results database.

**May I submit my abstract to the 2025 ACCP Annual Meeting if it was already presented at another meeting?**

Original research findings presented elsewhere, but important to clinical pharmacy, are encouraged as “Encore” submissions.

- Abstracts submitted for Encore Presentations must not be modified from the previously presented/published version. This includes the title, authors, and abstract body. The presenting author may change, but the presenting author must be an author on the original abstract.
- The same abstract may not be presented at more than one national ACCP event.
- Only the abstract title and authors will be published in *JACCP*.

**May I submit work that was already published as a manuscript?**

No. The submitting author must verify at the time of submission that the manuscript will *not* have been published *prior to* presentation at the 2025 ACCP Annual Meeting.

**If I am a co-author on an abstract, can I give the presentation?**

Yes. The person presenting the poster MUST be listed as an author on the corresponding abstract (including Encore Presentations).

**If I am unable to attend the 2025 ACCP Annual Meeting to present my poster, will my abstract still be published in *JACCP*?**

No. All posters MUST be presented by an author at the assigned time for it to be published in an official journal of ACCP after the meeting. Important Note: All accepted abstracts presented during the Annual Meeting, excluding "Encore" and "Research-in-Progress" posters, will have full-text abstracts published online in the *Journal of the American College of Clinical Pharmacy (JACCP)*. Only the abstract title, authors, and original citation will be published for "Encore" presentations.
