

2023 ACCP/ASHP Ambulatory Care Pharmacy Preparatory Review and Recertification Course: Financial Disclosures

In accordance with the Accreditation Council for Continuing Medical Education's Standards for Commercial Support and the Accreditation Council for Pharmacy Education's Standards for Commercial Support, ACCP and ASHP requires that all individuals involved in the development of activity content disclose their relevant financial relationships.
