**Chapter: Implementing an Antimicrobial Stewardship Program**

**Learning Objectives**

1. Justify the necessity and resources of an antimicrobial stewardship program (ASP) to organizational leadership.

**Chapter: Opioid Crisis and Opioid Stewardship**

2. Assess adolescent patients using appropriate screening tools for opioid misuse or use disorder and evaluate if brief intervention or referral for treatment is needed.
3. Demonstrate a practice approach that supports treatment expansion of medications for opioid use disorder and differentiate pharmacologic treatments for detoxification and maintenance.
4. Develop mitigation strategies centered on opioid stewardship to promote appropriate pain management, prescribing reductions, naloxone distribution, and other harm reduction methods.

**Chapter: Mass Vaccination and Herd Immunity**

**Interactive Case: Oral HIV Preexposure Prophylaxis**

**Learning Objectives**

3. Design a treatment plan for PrEP initiation in a high-risk teenager, including ongoing medical management.

5. Devise strategies to overcome common barriers related to PrEP, specifically barriers affecting adolescents.

**Interactive Case: Vaccine-Preventable Diseases and Postexposure Prophylaxis**

**Learning Objectives**

1. Evaluate contraindications and timing considerations of vaccines in patients receiving antibody-containing therapies or with secondary immunodeficiencies.
2. Develop treatment plans for postexposure prophylaxis of common vaccine-preventable diseases in pediatric patients.
3. Distinguish the need for additional vaccination and antimicrobial chemoprophylaxis in certain patient populations.
