Position Clinical Pharmacists

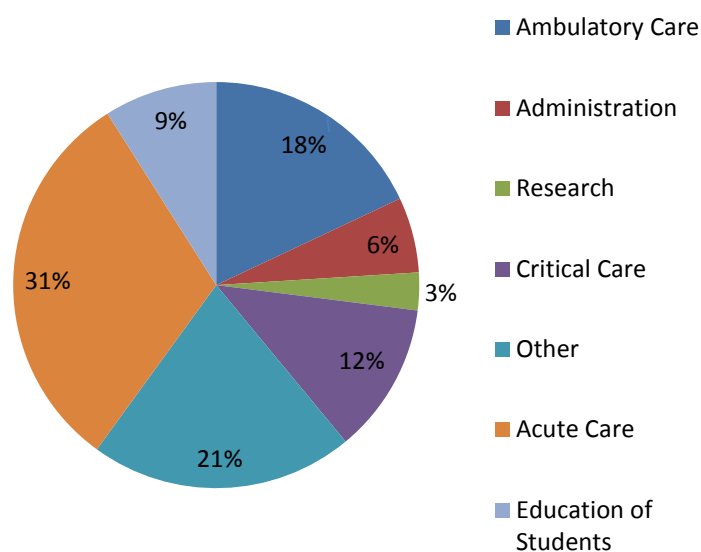
- Communicate with external constituencies to foster recognition of clinical pharmacists' collaborative contributions to patient care

ACCP Member Postgraduate Training, Credentialing, and Privileging

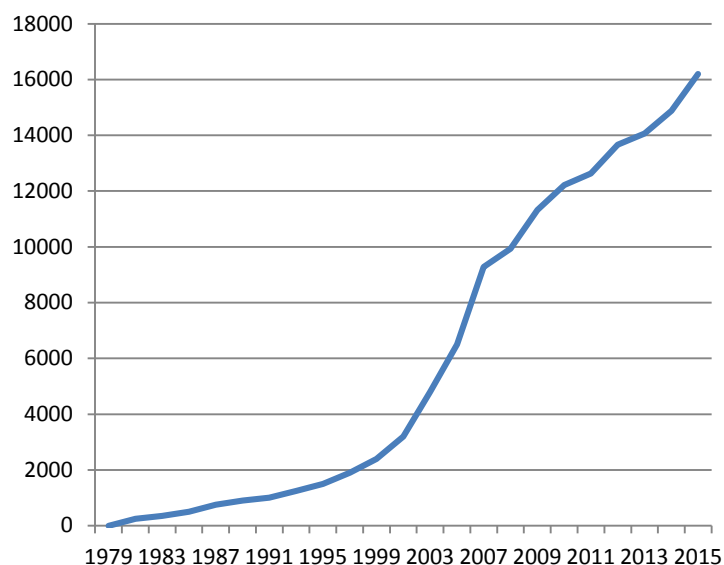
