In accordance with the Accreditation Council for Continuing Medical Education's Standards for Commercial Support and the Accreditation Council for Pharmacy Education's Standards for Commercial Support, ACCP requires that all individuals involved in the development of activity content disclose their relevant financial relationships with any ineligible companies that they have had over the past 24 months.
