ACCP Government and Professional Affairs Update: Assessing ACCP's Advocacy Strategy in 2025

Donald J. Trump was sworn in as the 47th president of the United States on January 20, claiming an "unprecedented and powerful mandate" to



dramatically overhaul the apparatus of the federal government. With Republican majorities in the House and Senate and a conservative-leaning Supreme Court, the new administration is in an advantageous position to advance its policy agenda.

With a series of Executive Orders, the Trump Administration initiated a new era of "policy unknowns" characterized by a lack of clearly communicated guidelines and an absence of predictable process. Acknowledging the rapidly evolving regulatory environment of the Trump administration, ACCP is working to maintain its strategic, evidence-driven approach to advocacy while remaining vigilant and responsive in support of regulatory structures and conventions that delineate and facilitate the clinical practice of its members.

Capitol Hill Strategy

Both independently and as part of a multi-organizational coalition, ACCP has been active on Capitol Hill and has already held meetings with some of the leading offices in the Senate Finance Committee and House Ways and Means Committee.

ACCP-PAC is the political voice of the clinical pharmacy profession and will be a key advocacy tool throughout the 119th Congress. ACCP-PAC <u>recently attended an event hosted by Rep. Buddy Carter (R-GA)</u>, a pharmacist currently serving in the US Congress who was recently elected as chair of the Health Subcommittee on Energy and Commerce, with jurisdiction over Medicare issues.

ACCP-PAC is nonpartisan and is the only federal political action committee dedicated specifically to advancing the practice of clinical pharmacists and the care of their patients. The College supports candidates whose perspectives align with ACCP's mission to advance the profession and improve human health and who have demonstrated leadership on issues important to ACCP members, such as protecting Medicare funding for pharmacy residencies. ACCP Organizational Statement: Medication Optimization Requires Scientific Research and Clinical Evidence

The following is a statement from Jo Ellen Rodgers, Pharm.D., FCCP, FHFSA, FAHA, BCPS, BCCP, CPP, president of the American College of Clinical Pharmacy.

The mission of the American College of Clinical Pharmacy is to improve human health through the science and practice of rational medication use. Our members provide high-quality patient care, promote the generation of innovative science, and disseminate new knowledge to advance pharmacotherapy.

The practice of clinical pharmacy requires the application of specialized knowledge of pharmacotherapy and evidence-based treatments. In their daily practice, clinical pharmacists collaborate with physicians and other health care providers to develop and implement patient-centered medication plans that improve health outcomes. The often complex and nuanced therapeutic interventions made by clinical pharmacists require that they have full access to scientific research and evidence-based treatment guidelines.

The standards of patient care developed in America's health care institutions are built on evidence-based practices made possible by shared, transparent data generated through peer review of scientific research. To maintain these standards, clinical pharmacists must continue to have full access to scientific research. In addition, ongoing collaboration and communication between policy leaders across all levels of government and health care stakeholders are vital to ensure patient safety.

We urge government leaders at the federal level to maintain and uphold long-established practices that guarantee scientific evidence is freely and publicly available and to continue to invest in health-related programs and agencies that are essential to providing the best care for our patients.

Webb Named Recipient of Prestigious BPS Weaver/Penna Award



Dr. C. Edwin "Ed" Webb, former director of Government and Professional Affairs and ACCP associate executive director, has been named the recipient of the 2025 Board of Pharmacy Specialties (BPS) Warren E. Weaver/Richard P.

Penna Award. The award recognizes individuals who have made outstanding voluntary contributions to the advancement of BPS board certification of pharmacists.

Webb joined ACCP in April 2000 as its inaugural director of Government and Professional Affairs and shortly thereafter established a new College office in Washington, DC. He retired in July 2018. Before coming to ACCP, he worked in professional affairs at the American Pharmaceutical Association (now the American Pharmacists Association) and in professional/government affairs at the American Association of Colleges of Pharmacy. He was instrumental in the work of the multi-organizational Council on Credentialing in Pharmacy to provide guidance, standards, and promotion of the profession's credentialing, accreditation, and certification efforts.



Webb's involvement with BPS began at the American Pharmacists Association, where he supported early recognition of pharmacotherapy and nutrition support as specialties. His most impactful work, however, came during his tenure at ACCP. He was a principal force behind ACCP's policy and position statements on the importance of BPS board certification in defining the clinical pharmacist. He spearheaded the development of 6 petitions for specialty recognition, including ambulatory care and critical care.

A strong advocate for comprehensive medication management and interprofessional practice, Webb has championed the work of board-certified clinical pharmacists within team-based models through his work with the Primary Care Collaborative, the Get the Medications Right Institute, and the National Academy of Medicine.

BPS will present the award to Webb during the Opening General Session of the 2025 ACCP Annual Meeting in Minneapolis, Minnesota, on Saturday morning, October 18.

ACCP Member Spotlight: Omolola (Lola) Adeoye-Olatunde



Omolola (Lola) Adeoye-Olatunde, Pharm.D., MS, is a Darr-Chaney Assistant Professor of Pharmacy Practice at Purdue University College of Pharmacy and the founder and principal investigator of the Health Equity Research (HER) Lab. She also serves as the director of Community

Engagement and Evaluation for the Center for Health Excellence Quality and Innovation (CHEQI) and co-director of the Community Health Workforce Development Institute (CHWDI) at Purdue University. Adeoye-Olatunde earned her Pharm.D. degree from Massachusetts College of Pharmacy and Health Sciences University in 2016. She completed a postgraduate year one (PGY1) community-based residency at Kroger Pharmacy. She received advanced training with a master's of science degree in health services, outcomes, and policy and a community practice research fellowship at Purdue University in 2020.

As the founder and principal investigator of HER Lab, Adeoye-Olatunde leads efforts to design, implement, and evaluate public health interventions for communities that are under-resourced. Her projects address adverse social determinants of health, promote accessible health services, and support culturally responsive solutions to public health challenges. She engages local, national, and global organizations to co-create sustainable programs meeting community needs. In her roles at CHEQI and CHWDI, Adeoye-Olatunde fosters interdisciplinary partnerships, mentors students and collaborators, and drives workforce development initiatives. Her

projects focus on translating research into actionable, community-centered public health solutions. Adeoye-Olatunde is dedicated to addressing systemic barriers in public health, advocating for policy transformation, and leading innovative programs that improve access and mitigate health disparities. Her multifaceted responsibilities highlight her commitment to creating and sustaining impactful public health interventions that align with the unique needs of communities served. Her work is funded by agencies such as the National Institutes of Health and the Indiana Department of Health, and she has earned multiple accolades, including the Top 40 Under 40 Health Leader recognition by the National Minority Quality Forum, the Bowl of Hygeia Award, and the Academy Health Alice S. Hersh Emerging Leader Award.

Adeoye-Olatunde's career has been most influenced by her father, a Nigerian immigrant and the first Black independent pharmacy owner in Decatur, Illinois. Coming from humble beginnings as the eldest of 21 children, he pursued his education with determination and defied all odds to build a legacy of service and resilience. Despite facing discrimination and predictions of failure because of his accent, he and his wife founded Victory Pharmacy, a trusted health care hub, particularly for the Black community in Decatur. For more than 15 years, he ensured community members had access to health care by going directly to where they were. He eventually expanded his business to Calumet City before retiring. Her father's journey instilled in her a passion for serving communities that are under-resourced and providing accessible, community-centered health care, which she now pursues through her roles in education and research. His faith, determination, and commitment to community care are principles she carries forward in her work every day.

Through her roles at Purdue University, Adeoye-Olatunde has been privileged to transcend traditional health care roles by fostering interprofessional collaboration and addressing health disparities. As director of Community Engagement and Evaluation for the CHEQI and co-director of CHWDI, she collaborates on initiatives that integrate pharmacy and public health disciplines to tackle complex local health challenges. Across her roles, there is an overarching focus on addressing unmet needs through interdisciplinary collaboration in communities that are under-resourced. She has the privilege of engaging students, faculty, and community partners in transformative projects that prioritize reciprocal relationships, equitable resource distribution, and shared decision-making. Key initiatives including the Community Health Access Model Partnerships and the innovative interdisciplinary Cardiovascular Risk Reduction Clinic exemplify how interdisciplinary

collaboration creates real-world impact. These projects address the effects of the COVID-19 pandemic, food insecurity, and substance use while also providing cardiovascular care and addressing social determinants of health challenges. The outcomes include improved access to care, enhanced preventive services, and better health outcomes for populations that are underresourced. By embracing a community-first approach and leveraging interprofessional collaboration, she works to build sustainable systems that transcend traditional roles, advancing accessible health care and improving outcomes for communities that are under-resourced.

Creating a safe environment where all team members feel valued, respected, and heard is a cornerstone of her leadership philosophy. Recently, Adeoye-Olatunde completed a DEI Leadership Certificate program, during which she developed a leadership legacy statement that encapsulates her approach: "As a leader, I strive to create a lasting environment of community, excellence, and possibility, so that we feel valued, supported, and equipped to do impactful work, achieve our individual and collective goals, while enjoying the process."

She brings this statement to life by fostering inclusivity among racially, ethnically, intellectually, and culturally diverse team members through intentional efforts.

This includes having open, authentic conversations that acknowledge and embrace differences. In addition, she invests in external professional resources to equip both herself and her team with the skills and tools to navigate and celebrate diversity effectively. She prioritizes creating a joyful and engaging work environment. Humor is a big part of how she connects with her team because it builds camaraderie and eases tension. They celebrate both small and large milestones—whether it's completing a project or simply making progress—and often share meals to mark the occasion. These practices foster a sense of belonging and connection, making the process of achieving goals as meaningful and rewarding as the outcomes themselves.

2025 ACCP Oncology Genomics Certificate Program Begins March 4

This unique certificate program blends interactive live online learning (via Zoom) with self-study programming to equip clinical pharmacists with the necessary skills to apply oncology genomics to practice. This year from March 4 through May 19, participants will acquire the skills to interpret genomic reports, develop treatment plans on the basis of genomic data, interact with an interprofessional molecular oncology team, and learn strategies for implementing a molecular tumor board at their own institutions.

Expert faculty will lead weekly online sessions that provide foundational knowledge about somatic genomics and next-generation sequencing (NGS) and necessary tools for interpreting NGS reports to develop effective treatment plans. Faculty will delve into pertinent oncology specialty topics, including lung cancer genomics, gynecologic cancer genomics, and hematologic malignancies. Strategies for implementing a molecular tumor board will be demonstrated together with an exploration of related ethical, legal, and social issues for consideration. Participants will have the opportunity to join in facilitated discussions, receive mentorship to solidify learning, and gain practice through practice sessions and case-based presentations with peers. Self-study modules and exercises will reinforce program topics.

2025 ACCP Clinical Research Challenge Competition Underway



ACCP is pleased to announce that competition is underway in the tenth annual Clinical Research Challenge (CRC). Research and scholarship contributes to improved health outcomes for patients and advances in the

profession of clinical pharmacy. Critically evaluating and applying primary literature is an essential skill for students pursuing a career in clinical pharmacy.

This innovative and unique competition offers teams of 3 students (those in the first 2 professional years of their degree program) the opportunity to compete in Round 1: The Online Journal Club. Teams achieving the top 40 scores will advance to Round 2: Letter of Intent Submission. Teams with the top 20 scores after round 2 will advance to the third and final round: Research Protocol Development.

The 2025 competition began February 10 with 79 teams vying for a spot in round 2. Teams advancing to round 2 will be given a clinically focused research question and have 2½ weeks to develop and submit a letter of intent following the criteria outlined here. Teams advancing to round 3 will be announced on March 24.



NCICLE Releases New Resource for Maintaining Well-Being in the Interprofessional Clinical Learning Environment

The National Collaborative of Interprofessional Clinical Learning Environment (NCICLE) has released a second set of resources and tools for achieving the goals of their 2021 Pathways to Excellence: Expectations for an Optimal Interprofessional Clinical Learning Environment to Achieve Safe and High-Quality Patient Care. The Well-Being Resources Compendium is made up of over 30 resources from the 41 NCICLE member organizations on achieving and maintaining well-being among all members of the health care team. The resources include evidence-based research, webinars and learning modules, well-being programs, and practical toolkits. This compendium joins the Teaming Resource Compendium, released in 2024, which includes over 40 resources on developing and maintaining high-functioning interprofessional teams.

The NCICLE Pathways document, as well as the annual resources, was developed to serve as a tool for health care professionals to evaluate their own clinical learning environments (CLEs) and assist them in guiding discussions with institutional leaders to design the necessary infrastructure and processes to optimize both learning and patient care. The document focuses on 6 pathways: patient safety, health care quality, teaming, supervision of learners, well-being, and professionalism. It stresses the value of interprofessional collaboration in continually assessing and improving environments where the health care workforce trains and reinforces the mutual roles of learners and those educating them in promoting high-quality team-based care.

NCICLE is a collaborative representing medicine, pharmacy, nursing, physical and occupational therapy, and social work, as well as professional accrediting bodies, the Joint Commission, and national health



care organizations such as the Institute for Healthcare Improvement, the Institute for Safe Medication Practices, the American Red Cross, and the Veterans Health Administration. ACCP joined NCICLE in April 2021 to expand the College's interprofessional collaborations and promote the role of clinical pharmacists as interprofessional educators in CLEs. ACCP members are encouraged to explore the newly updated NCICLE.org website and share the well-being resources with their colleagues. By prioritizing well-being, we can continue to create environments where health care professionals and learners thrive.

National Academies Innovations in Pharmacy Training and Practice to Advance Patient Care: A Workshop

Abstract Submission: Future of Pharmacy Poster Session

A planning committee of the National Academies of Sciences, Engineering, and Medicine (the National Academies) has organized a public workshop, <u>Innovations in Pharmacy Training and Practice to Advance Patient Care</u>, on May 29 and 30, 2025. The workshop will examine recent trends in the field of pharmacy and consider strategies for improving the pharmacy workforce to advance patient care and outcomes.

The workshop is designed to address:

- Ways to enhance the pharmacy workforce, eliminate pharmacy deserts, and reduce health disparities in rural, suburban, and urban areas
- Strategies to create collaborative care environments that reduce clinician burnout and enable pharmacists to train and work in a safe and supportive environment
- Programs in which pharmacists have expanded roles in health care delivery
- Next-generation training programs that can prepare pharmacists for expanded roles beyond direct patient care

The workshop will be held at the National Academies' Keck Center in Washington, DC.

- 5. Prioritizing the well-being of the pharmacy workforce by creating policies to mitigate burnout (a key component of the quintuple aim of high-quality health care).

Individuals can submit up to 2 abstracts as an author or coauthor (less than 400 words/abstract). De-identified abstracts will be reviewed by workshop planning committee members.

All accepted abstracts will be shared with the workshop participants and may be published in the workshop proceedings; however, only those attending in person will be able to participate in the poster session (ie, there will NOT be a virtual poster presentation option). If accepted, the corresponding author must indicate whether they are attending the workshop in person.
