After nomination by their colleagues, Fellow candidates undergo a comprehensive and rigorous evaluation by the Fellowship Subcommittee of the Credentials Committee of their practice and/or research accomplishments. Among the criteria evaluated by the committee are examples of patient care service or educational programs developed by the nominee; certifications or other credentials earned; drug

therapy management responsibilities; educational presentations; consultantships; service to publications; original research presentations, projects, funding, and publications; and other awards. Persons nominated as a Fellow also must have made a substantial contribution to ACCP through activities such as attendance or presentation at College-sponsored meetings; service as an abstract, Research Institute, or Pharmacotherapy reviewer; contribution to College publications; or service as a committee member, Practice and Research Network, chapter officer, or elected officer.

# Research Institute Provides Nearly \$400K for Fellowships and Research Awards in 2004

## Includes First Frontiers Research Awards

The ACCP Research Institute Board of Trustees has announced the recipients of its 2004



Fellowships and its Investigator Development, Career Development, and Frontiers Research Awards. Fellowships provide stipend support for an intensive research training experience for a developing clinical pharmaceutical scientist. The Investigator Development Research Awards provide \$15,000-\$20,000 to support specific research projects by ACCP members who are five or fewer years since completion of their formal training or first academic appointment. This is the third year that the ACCP Career Development Research Award has been given. It provides \$50,000 over two years to support the research of a College member who is more than five years since completion of his/her formal training or first academic appointment.

New this year are the ACCP Frontiers Research Awards. Supported by generous contributions to the Frontiers Fund by College members and others, these grants support either clinical or pharmacy-related health services (practice) research in areas of unmet need. Based on Frontiers Fund contributions received during 2003, the ACCP Research

Institute was able to fund nearly \$143,000 in new health services and clinical research this year. The Frontiers Fund's goal in 2004 is to further expand its support of important research that benefits patient care and the practices of all ACCP members to at least \$250,000.

Research Awards will be recognized during a

special Research Institute program at ACCP's 2004 Annual Meeting in Dallas, TX. Recipients will present the results of their research at a future ACCP Annual Meeting.

All fellowship and research award proposals were evaluated by an expert review panel and by the Institute's Grants and Fellowships Selection Committee, one member of which served as the primary reviewer for each Fellowship or Research Award competition. A conference telephone call was held for each review panel, during which a consensus review of each proposal and recommendation regarding funding was developed. During the selection committee meeting, the primary reviewer summarized the panel's discussions and recommendations, and a recipient was chosen for each Research Award or Fellowship.

An important feature of the Research Institute's grants review process is that a summary evaluation is provided to all applicants to assist them in preparing future grant applications. Prepared by the category's primary reviewer, this consensus evaluation integrates the recommendations of all four reviewers. In addition to complementing the proposal's strengths, it provides guidance to enhance future grant applications.

A call for proposals for the 2005 Fellowships and Research Awards will be issued this fall. Watch your e-mailbox and future issues of the *ACCP Report* for additional information and application deadlines.

Medication Therapy
Management ... Ready for
Prime Time

The inclusion of medication therapy management services (MTMS) as a required component of the new Medicare outpatient pharmacy benefit that will begin in 2006 represents an important milestone in the evolution of pharmacy as a patient-centered profession. Prescription drug plans that choose to offer a Medicare drug benefit (known as the "Part D" benefit) will be required to incorporate MTMS into the benefit structure in a manner that conforms with the requirements of the Medicare Modernization Act of 2003 (MMA), and are required to develop the services in consultation with practicing pharmacists and physicians. These services will be targeted to Medicare patients with multiple chronic diseases who are taking multiple prescription medications and whose medication spending exceeds threshold levels that may be established by the Secretary of Health and Human Services.

And yet, MTMS remains a somewhat unfamiliar concept to the majority of people outside of pharmacy, as well as some within pharmacy. What, exactly, constitutes MTMS? Who provides them? How do they differ from more traditional services of pharmacists related to the processes associated with the dispensing of a prescription drug product? And how will payment be structured for these services? The answers to these questions are starting to emerge as the MMA moves toward implementation through

the promulgation of regulations by the Centers for Medicare and Medicaid Services (CMS).

Some ACCP members may feel that the answers to these questions should be obvious. Much of the daily practice activity of many clinical pharmacists could reasonably be characterized as "medication therapy management." And while an explicit definition may not be found in Stedman's Medical Dictionary, many ACCP members would likely say that they know exactly what MTMS are because "that is what I do." Nevertheless, helping those who may not be as familiar with these services and activities, but who will have administrative responsibility for their development, implementation, and regulation, is a critically important task now before pharmacy's national professional organizations. This is particularly important because the payment structure for MTMS under this new benefit will be determined by the prescription drug plan, and payments that come to pharmacists will be from the plans, not directly from Medicare beneficiaries.

Since the passage of MMA in late 2003, ACCP, working with partner organizations of the Pharmacist Provider Coalition (PPC) has engaged in discussions and working sessions to develop and promote a set of core principles of MTMS that have subsequently been shared with many relevant parties, including CMS Administrator Dr. Mark McClellan during a meeting with PPC organization executive staffs in June, as well as executives of health plans and prescription benefits managers in an "executive session" hosted by the American Society of Health-System Pharmacists and the Academy of Managed Care Pharmacy. Later in June, under the leadership of the American Pharmacists Association, an invitational conference was held to seek profession-wide consensus on a definition for MTMS and related program criteria. That effort has resulted in the completion of a document, a substantial portion of which is based on the PPC core principles, that has been officially endorsed by all 11 major national pharmacist and pharmacy organizations. The "MTMS Definition and Program Criteria" document is found at the end of this column.

Most recently, on August 3, CMS published its proposed rule concerning the implementation of several components of the MMA, including the outpatient drug benefit, in the Federal Register. ACCP staff has begun its analysis of the proposed rule and will develop a comprehensive comment letter for submission to CMS, articulating the College's relevant policies and perspectives, with particular emphasis on the MTMS provisions of the proposed rule. The comment period closes on October 3, 2004. The principal portion of the rule related specifically to the MTMS provisions can be found on pages 38–40 of the document (pages 46668–70 of the actual rule) associated with the link above, although the entire rule contains more than 60 references to medication therapy management. ACCP members may wish to review the proposed rule and comment directly to CMS as provided for in the notice. Alternatively, ACCP staff would welcome your comments for (continued on page 5)

consideration as we begin to develop the College's comment letter over the next two or three weeks.

The encouraging news is that the initial review of the proposed rule demonstrates that many of the key concepts contained in the profession's consensus document are acknowledged, and even endorsed, by CMS as it seeks to provide guidance to entities that will be offering the Part D benefit. The more sobering news is that the rule asks as many questions as it seeks to answer, acknowledging that "neither we, nor many private insurers, have extensive

experience requiring or reimbursing for MTMP's." [Ed. note: MTMP refers to Medication Therapy Management Program.] This presents both a challenge and some opportunities.

The success of pharmacist organizations in the legislative effort to incorporate MTMS into the MMA must now be capitalized on by continuing to work together to ensure that implementation of the law results in an MTMS benefit that does indeed position pharmacists to help beneficiaries achieve improved outcomes from their use of medications. Pharmacists will be in the spotlight as never before as this important new program emerges in 2006. "Prime time" has arrived.

## Pharmacy Profession Stakeholders Consensus Document July 7, 2004

#### Medication Therapy Management Services -- Definition and Program Criteria

Medication Therapy Management is a distinct service or group of services that optimize therapeutic outcomes for individual patients.

Medication Therapy Management Services are independent of, but can occur in conjunction with, the provision of a medication product.

Medication Therapy Management encompasses a broad range of professional activities and responsibilities within the licensed pharmacist's, or other qualified health care provider's, scope of practice. These services include but are not limited to the following, according to the individual needs of the patient:

- a. Performing or obtaining necessary assessments of the patient's health status;
- b. Formulating a medication treatment plan;
- c. Selecting, initiating, modifying, or administering medication therapy;
- d. Monitoring and evaluating the patient's response to therapy, including safety and effectiveness;
- e. Performing a comprehensive medication review to identify, resolve, and prevent medication-related problems, including adverse drug events;
- f. Documenting the care delivered and communicating essential information to the patient's other primary care providers;
- g. Providing verbal education and training designed to enhance patient understanding and appropriate use of his/her medications;
- h. Providing information, support services and resources designed to enhance patient adherence with his/her therapeutic regimens;
- i. Coordinating and integrating medication therapy management services within the broader health care-management services being provided to the patient.

A program that provides coverage for Medication Therapy Management services shall include:

- a. Patient-specific and individualized services or sets of services provided directly by a pharmacist to the patient.\* These services are distinct from formulary development and use, generalized patient education and information activities, and other population-focused quality assurance measures for medication use.
- b. Face-to-face interaction between the patient\* and the pharmacist as the preferred method of delivery. When patient-specific barriers to face-to-face communication exist, patients shall have equal access to appropriate alternative delivery methods. MTM programs shall include structures supporting the establishment and maintenance of the patient\*-pharmacist relationship.
- c. Opportunities for pharmacists and other qualified health care providers to identify patients who should receive medication therapy management services.
- d. Payment for Medication Therapy Management Services consistent with contemporary provider payment rates that are based on the time, clinical intensity, and resources required to provide services (e.g., Medicare Part A and/or Part B for CPT & RBRVS).
- e. Processes to improve continuity of care, outcomes, and outcome measures.
- \* In some situations, Medication Therapy Management Services may be provided to the caregiver or other persons involved in the care of the patient.

#### **Pharmacotherapy Pearls**

#### **Pharmacotherapy Goes Online**

It is with great excitement that we announce the availability of Pharmacotherapy online. Beginning July 1, 2004, Pharmacotherapy has become available in PDF format online, free of charge, to all subscribers. Pharmacotherapy has been available as a traditional print journal since 1981. Beginning in 2000, the entire contents of the journal (including all supplements) became available free of charge online at Medscape.com (http://www.medscape.com/ viewpublication/132\_index) from volume 19, number 1, to the present. Although Medscape has allowed the world to access and appreciate the clinical knowledge tucked between the covers of *Pharmacotherapy*, their downloads are in HTML, whereas the world is clamoring for PDFs. As Medscape grew, the time between publication of the print issue and the posting of our articles online began to increase. In addition, only selected articles are now being posted. Our solution to these dilemmas was to create our own Web site that performs all of the functions that our readers and authors have been requesting and to have the features in place that presage future requirements.

Beginning with securing the Web address <a href="http://www.pharmacotherapy.org">http://www.pharmacotherapy.org</a>, we sought to incorporate the features into our Web site that were considered most desirable by our readers and authors, and met the needs of researchers and clinicians. Armed with our wish list, we began a systematic analysis of the companies that work with scientific journals to create a customized online presence. After careful analysis, we chose Extenza, a subsidiary of Swetts/Blackwell. At that point, we began the long process of converting <a href="https://pharmacotherapy">Pharmacotherapy</a> articles to PDF files, creating lists of key words for each article to enhance online searching, and translating our subscriber databases into a format that will allow online access to all of our subscribers.

Among the features that all subscribers will enjoy are the unlimited downloading of PDF articles published in *Pharmacotherapy* since January 1999, hot links from references (for all issues from 2002 forward), and a monthly table of contents e-mail alert that lets readers know which articles are to be published in the next issue. *Pharmacotherapy* is mailed from our printer on the first of each month. Coincident with that mailing, the journal will go live on our Web site. This online content will be free to *Pharmacotherapy* subscribers at *http://www.pharmacotherapy.org*.

By now, you should have received an e-mail from Extenza telling you how to log on to *Pharmacotherapy* online (the e-mail will be from the domain extenza.com). If you have not received such an e-mail from Extenza, that means we do not have your e-mail address. We must have your e-mail address

to send your initial login name and password. If you have not received the e-mail from Extenza, please send us your e-mail address as soon as possible to <code>ejournal@ppijournal.org</code>. If you are an ACCP member and have an e-mail address listed on your member profile, that means we have it. If you have not listed an e-mail address with ACCP or your e-mail address has changed, please go to <code>http://www.accp.com/ClinNet/change.cgi/member\_id</code> and update your e-mail address.

Once you have successfully logged in to the *Pharmacotherapy* page on Extenza, you will be able to change your screen name and password from the ones that are assigned to ones that are customized by you.

Our institutional subscribers will not be receiving individual login names but will have access via IP address recognition. Letters were sent out in May to our institutional subscribers, and we are pleased to say that most have already responded.

Because we want to be sure that *Pharmacotherapy* continues to be a leading knowledge source for clinicians and researchers, our online content will be fully searchable, not only on our Web site but through PubMed, the National Library of Medicine, and SwetsWise (a worldwide online resource consortium). Abstracts will continue to be freely available to all who visit our Web site. Full-text PDFs will be available to nonsubscribers at the very reasonable rate of only \$6 per article. If a nonsubscriber wishes to become a subscriber, online subscriptions will be available, with instantaneous access to the entire collection of online content. 
