

Boucher Named 2023 Parker Medalist



Bradley A. Boucher, Pharm.D., MCCM, FCCP, FNAP, has been chosen by the Parker Medal Selection Committee as the 2023 recipient of the College's Paul F. Parker Medal for Distinguished Service to the Profession of Pharmacy. At the time

of his nomination, Boucher was serving as interim dean at the University of Tennessee Health Science Center (UTHSC) College of Pharmacy. Immediately before holding the position of interim dean, he served as associate dean for Institutional Initiatives and Operations at UTHSC College of Pharmacy.

Paul Parker was one of clinical pharmacy's most influential proponents. Before his death in 1998, Parker spent 24 years as director of pharmacy at the Chandler Medical Center/University of Kentucky in Lexington. His innovations included developing decentralized pharmacy services, placing pharmacists in the hospital's clinical areas, and developing the nation's first pharmacist-staffed drug information center. Parker's vision for pharmacy practice was passed along to the more than 150 residents and fellows who trained in the Kentucky program during his tenure. These disciples included many of today's leaders in clinical pharmacy who continue to pass along his wisdom and vision to their trainees and colleagues. The Paul F. Parker Medal recognizes an individual who has made outstanding and sustained contributions to the profession that improve patient or service outcomes, create innovative practices, affect patient populations, further the professional role of pharmacists, or expand the recognition of pharmacists as health professionals.

The Parker Medal Selection Committee chose Boucher as the 2023 medalist on the basis of his long-standing commitment to the pharmacy profession as an educator, clinician, and scholar.

Dr. Michael Kraft, a clinical professor in the Department of Clinical Pharmacy at the University of Michigan College of Pharmacy, wrote in his letter

supporting Boucher's nomination: "Considering his contributions to direct patient care, scientific literature, and the profession through professional organizations like ACCP, and the number of students and trainees he has mentored, his impact on the profession and patient care is arguably immeasurable," adding: "He embodied the clinician dedicated to patient care who set high expectations for students and trainees."

In his letter of support, Dr. Joseph Swanson, professor in the Department of Clinical Pharmacy and Translational Science and assistant director of Experiential Learning and International Programs at UTHSC College of Pharmacy, wrote:

Dr. Boucher's significant contributions to the medical literature are enviable. He has published over 120 manuscripts and 36 book chapters and has edited 13 books. The significance of his publications has resulted in improvements to the care of critically injured trauma patients and his manuscripts have been cited by clinical practice guidelines. The scope of his expertise is as impressive as the depth. He has published in areas including, but not limited to, hemostasis, traumatic brain injury, infectious complications in critically ill patients, and pharmacokinetic changes in the critically ill.

Dr. Boucher's sustained contributions to pharmacy organizations have helped to shape our profession. He led the Rho Chi Society as national President. His noteworthy contributions to the American College of Clinical Pharmacy (ACCP) are too numerous to list but include serving as Treasurer and President. More important than the titles he held is the leadership he provided. He has been elected as a Fellow in both ACCP and the American College of Critical Care Medicine. Dr. Boucher is one of only nine pharmacists in the world to have been honored with the status of Master of Critical Care Medicine, an honor that requires international recognition of one's clinical, scholarly, and service contributions.

In his supporting letter, Dr. Curtis Haas, chief pharmacy officer at the University of Rochester in Rochester, New York, wrote:

As a career-long academic pharmacist, Dr. Boucher has made sustained and significant contributions to pharmacy education and training, especially in the area of critical care pharmacy. He has maintained a clinical pharmacy practice site in neurotrauma intensive care for nearly forty years, and over that span of time has precepted hundreds of pharmacy students, medical students and other trainees. He has trained 9 critical care fellows, the majority of whom have gone on to have distinguished careers in clinical practice, research, academia, or industry. He co-founded a critical care specialty residency (PGY-2), and as a faculty member in that program has contributed to the training of more than 78 residents to date. This represents the largest number of critical care pharmacy trainees from a single residency program in the country. Many of the graduates of the program are widely recognized as leaders of critical care pharmacy practice, research, and education in the US.

His many invited lectures and scientific presentations reflect the evolution of critical care pharmacy practice over several decades with nearly every area of therapeutic controversy over the years represented. He has been sought out for many years to speak on these topics because of his recognized expertise in critical care therapeutics and bedside practice. His receipt of fellowship recognition in clinical pharmacy and critical care were based upon his excellence in clinical practice. He received the ACCP Clinical Practice Award in 2011 and the ACCP Critical Care PRN Achievement Award in 2017. The National Academies of Practice in Pharmacy recognized Brad as a Distinguished Practitioner and Fellow in 2004 and he was recently honored with the Robert G. Leonard Memorial Lecture Award in 2022.

During its deliberations, committee members noted that Boucher has made outstanding, significant, and sustained contributions to improving or expanding the profession of pharmacy. These contributions – not limited to scientific research – have helped advance the pharmacy profession and improve patient outcomes. Furthermore, his work reflects a lifetime record of contributions. He will be recognized at the [Awards and Recognition Ceremony](#) during the [2023 ACCP Annual Meeting](#) in Dallas, Texas. The ceremony will be held Sunday morning, November 12.

The Parker Medal Selection Committee is composed of leaders from member organizations of the Joint

Commission of Pharmacy Practitioners, together with past presidents of ACCP. Boylan, Bulman, and Kufel to Receive ACCP Honors

ACCP members Paul Boylan, Zackery Bulman, and Wesley Kufel were selected by the 2023 ACCP Awards Committee to receive the College’s prestigious 2023 New Educator, New Investigator, and New Clinical Practitioner awards, respectively. The awards will be presented in Dallas, Texas, on Sunday, November 12, 2023, during the [Awards and Recognition Ceremony](#) of the [2023 ACCP Annual Meeting](#).



The ACCP New Educator Award recognizes and honors a new educator for outstanding contributions to the discipline of teaching and to the education of health care practitioners. The awardee must have been a Full Member of ACCP at the time of nomination and a member at any level for a minimum of 3 years; in addition, the awardee must have completed their terminal training or degree less than 6 years previously. Paul M. Boylan, Pharm.D., BCPS, is an assistant professor of pharmacy practice at the University of Oklahoma College of Pharmacy (OUCOP) and serves as a clinical pharmacist at The University of Oklahoma Medical Center. Previously, Boylan was an assistant professor at Larkin University College of Pharmacy (LUCOP), where he practiced as a clinical pharmacist at Larkin Community Hospital – Palm Springs Campus. Boylan received his Pharm.D. degree from Wilkes University Nesbitt School of Pharmacy and completed residency training at Reading Hospital in West Reading, Pennsylvania (PGY1), and Nova Southeastern University College of Pharmacy in Fort Lauderdale, Florida (PGY2, transitions of care).

The Awards Committee noted in its report to the ACCP Board of Regents:

In terms of classroom innovation, Dr. Boylan has utilized techniques such as remote asynchronous lectures with adaptive learning and the flipped-classroom model. Additionally, he has authored 16 peer-reviewed publications and 1 book chapter and serves as co-investigator on a major grant focused on adult community-acquired pneumonia. Dr. Boylan was recognized in 2019 as the Class of 2021 Teacher of the Year at LUCOP and as the 2021 Most

Collegial Faculty Member, Class 2022 Educator of the Year, and 2022 Outstanding Educator at OUCOP. He was also awarded the 2022 Education and Training PRN Teaching and Mentoring Award. Dr. Boylan's colleagues describe him as a "bright, creative, and scholarly academician" and his students as "highly empathetic, very receptive, and student-centered." Dr. Boylan also tailors and individualizes student learning to better engage his learners in his courses. For example, he was able to increase student confidence in their drug information skills by integrating students' societal culture and background into his lectures. Dr. Boylan is an active member of the Pulmonary PRN, the Adult Medicine PRN, and the ACCP Task Force on Career Transitions.



The New Investigator Award recognizes an ACCP member who has made a significant impact on an aspect of clinical pharmaceutical science. The awardee must have been a member of ACCP for more than 3 years, must have completed their terminal training or degree less

than 6 years previously, and must have a research program with a substantial publication record that includes a programmatic theme or an especially noteworthy single publication. Zackery P. Bulman, Pharm.D., is an assistant professor in the Department of Pharmacy Practice at the University of Illinois Chicago (UIC) College of Pharmacy. He received a B.S. degree in biotechnology from Rochester Institute of Technology and a Pharm.D. degree from the University at Buffalo School of Pharmacy

and Pharmaceutical Sciences and completed an NIH-funded fellowship in infectious diseases pharmacology at the University at Buffalo. Bulman's research program investigates novel pharmacotherapeutic approaches to overcome drug-resistant bacteria and improve patient outcomes.

In recommending Bulman for the 2023 New Investigator Award to the ACCP Board of Regents, the committee wrote:

Dr. Bulman has obtained over \$4 million in research grants from the NIH and other competitive funding sources, including an NIH/NIAD R01 as PI to study precision medicine approaches to optimal antibiotic regimen selection specific to a patient's pathogen using bacterial genotypes. This 5-year award is among the largest R01 awarded to a Pharm.D. He has published 44 peer-reviewed publications, most within the past 3–5 years, and has an h-index of 17; his work has been cited more than 790 times. He has served as first or senior author on original research studies published in top infectious diseases journals such as *Lancet Microbe* (Impact Factor 86.2), *Journal of Antimicrobial Chemotherapy*, *Antimicrobial Agents and Chemotherapy*, and *Clinical Microbiology and Infection*. Dr. Bulman has authored two book chapters, provided multiple platform presentations at national and international meetings, and led international consortiums highlighting key areas for future research in infectious diseases. His expertise in the field of antimicrobial resistance and antibiotic

selection is reflected in numerous honors and awards, including recognition as a Fellow of the International Society of Antimicrobial Chemotherapy; Editor of *mSystems*, an American Society for Microbiology journal; and the 2022 UIC Research and Scholar of the Year Rising Star Award.

Bulman will deliver the annual New Investigator Award Lecture during the November 12 Awards and Recognition Ceremony.



The New Clinical Practitioner Award honors a new clinical practitioner who has made outstanding contributions to the health of patients and/or the practice of clinical pharmacy. The awardee must have been a Full Member of ACCP at the time of nomination, as well as a member at any level for a minimum of 3 years; in addition, the awardee must have completed their terminal training or degree less than 6 years previously. Wesley D. Kufel, Pharm.D., BCPS, BCIDP, AAHIVP, is a clinical associate professor of pharmacy practice at State University of New York (SUNY) Binghamton University and has been a clinical pharmacy specialist in infectious diseases at SUNY Upstate University Hospital in Syracuse, New York, since 2017. He received his Pharm.D. degree from the University at Buffalo School of Pharmacy and Pharmaceutical Sciences and completed residency training at SUNY Upstate University Hospital in Syracuse, New York (PGY1), and the University of North Carolina Medical Center in Chapel Hill, North Carolina (PGY2, infectious diseases).

The Awards Committee commented in its report to the ACCP Board of Regents:

Prior to his faculty appointment in 2017, there were no formal infectious diseases consult pharmacy services at his practice site, and since that time, Dr. Kufel has initiated several novel and innovative clinical programs. He has developed or helped optimize numerous pharmacist-led services, including the

Staphylococcus aureus bacteremia bundle, an antimicrobial stewardship discharge antibiotic prescription review program, a penicillin allergy management service, electronic antibiotic order sets, and a vancomycin AUC-based dosing and monitoring program. He is also the co-founder and current co-director of the Clinical Research Microcredential Program at SUNY Upstate and was appointed as a member of the Board of Pharmacy Specialties BCIDP specialty council (2023–2025). He was awarded the 2022 New York State ACCP Clinical Practitioner Award as well as the 2021 New York State Council of Health-System Pharmacists New Practitioner Award.

Kufel is also actively engaged in research and scholarship. At the time of his nomination, he had published over 45 peer-reviewed articles and held an h-index of 15 according to Google Scholar. In addition, he has received almost \$200,000 in extramural grant funding to support his various clinical research initiatives.

2023 ACCP Clinical Pharmacy Challenge: Online Team Registration Deadline: September 5, 2023



ACCP’s novel pharmacy student team competition returns for its 12th season. The ACCP Clinical Pharmacy Challenge offers eligible teams the opportunity to compete in up to four online rounds, with the top eight teams in 2023 advancing to the live quarterfinal competition at the [2023 ACCP Annual Meeting](#) in Dallas, Texas. Team registration is now available [online](#). **Act now to register your team by September 5.**

Competition Overview

The ACCP Clinical Pharmacy Challenge is a team-based competition in which teams of three students compete against teams from other schools and colleges of pharmacy in a “quiz bowl”-type format. Only one team per institution can enter the competition. Institutions with branch campuses, distance satellites, and/or several interested teams are encouraged to conduct a [local competition](#). ACCP provides a local competition exam that institutions may use in selecting their team. Faculty

members interested in using the exam may send an email request to Michelle Kucera, Pharm.D., BCPS, at mkucera@accp.com.

Preliminary rounds of the national competition will be conducted virtually in September. The quarterfinal, semifinal, and final rounds will be held live on November 11–13 at the 2023 ACCP Annual Meeting in Dallas.

Each round will consist of questions offered in the three distinct segments indicated below. Item content used in each segment has been developed and reviewed by an expert panel of clinical pharmacy practitioners and educators.

- Trivia/Lightning
- Clinical Case
- Jeopardy-style

Each team advancing to the quarterfinal round held at the 2023 ACCP Annual Meeting will receive three complimentary student full-meeting registrations. Each team member will receive an ACCP gift certificate for \$125 and a certificate of recognition. In addition, semifinal teams not advancing to the final round will receive a semifinal team plaque for display at their institution. The second-place team will receive a \$750 cash award (\$250 to each member) and a commemorative team plaque. The winning team will receive a \$1500 cash award (\$500 to each member), and each team member will receive a commemorative plaque. A team trophy will be awarded to the winning institution.

Students are not required to be members of ACCP to participate. Team registration can be submitted online and must be initiated by a current faculty member at the respective institution. Students interested in forming a team should contact their ACCP [faculty liaison](#). If no ACCP faculty liaison has been identified, any faculty member from the institution can initiate the registration process. The registering faculty member must confirm the eligibility of all team members and alternates online before a team will be permitted to compete in the Clinical Pharmacy Challenge. **The deadline to complete team registration and confirm eligibility is September 5, 2023.**

Washington Report ACCP Members Support College's Response to Congressional Initiative on Drug Shortages

On June 12, 2023, Senator Mike Crapo (R-ID) and Representative Cathy McMorris Rodgers (R-WA) issued a bicameral Request for Information (RFI) seeking input on policy solutions to the increase in drug shortages. The RFI followed a [U.S. Senate Committee on Homeland Security report](#) that showed a 30% increase nationwide in drug shortages between 2021 and 2022.

The bicameral RFI cited a May 2023 [study from the Office of the Assistant Secretary for Planning and Evaluation](#) indicating that drug shortages not only force those living with even the most serious medical conditions to seek out alternatives or experience debilitating lapses in care, but also trigger a variety of direct and indirect detrimental costs for both patients and front-line health care providers.

The RFI requested input on two areas of particular interest to ACCP:

- How can federal agencies, such as the Centers for Medicare & Medicaid Services (CMS), better

address the economic forces driving the shortages? Are these agencies using their current authorities effectively?

- Are there any guardrails that Congress should consider related to demonstration projects, including through the CMS Innovation Center, that would help protect against drug shortages? Are there any proactive demonstrations that would prevent drug shortages?

ACCP Member Engagement

Like all of its initiatives, ACCP's work in Washington, DC, is driven by its members. ACCP leaders have been integral in supporting the Government and Professional Affairs team in its efforts to secure key meetings with leaders on Capitol Hill. Because of the lobbying efforts of Rex W. Force, Pharm.D., FCCP, BCPS, at Idaho State University, ACCP staff secured a meeting with senior policy advisers to Senator Crapo, who serves as the ranking member on the powerful Senate Finance Committee with jurisdiction over Medicare. ACCP Drug Shortages Response

ACCP used this occasion to urge Congress and CMS to consider opportunities to integrate coordinated, team-based comprehensive medication management (CMM) provided by clinical pharmacists into Medicare coverage and payment models. Problems related to medication misuse generally fall under three major categories: overuse of medications that don't improve health and may cause harm, underuse of critical drugs needed for acute or chronic health problems, and misuse of medications such as opioids.

All three are contributing to the growing issue of drug shortages as well as driving higher costs and adversely

affecting patient health. According to the Get the Medications Right (GTMRx) Institute, “to prevent over-use of medications, health care providers shouldn’t start or continue medications without a comprehensive evaluation of the patient’s health issues and medications.”

ACCP highlighted the fact that many of the Medicare Merit-Based Incentive Payment System performance measures established under the Medicare Access and CHIP Reauthorization Act already directly pertain to medication use. The Comprehensive Primary Care Plus (CPC+) Program Year 2 Care Delivery Requirements administered by the Medicare Innovation Center (CMMI) included access to CMM services for patients discharged from the hospital and those receiving longitudinal care management that would involve the development of an individualized action plan addressing a patient’s medication problem list and a review of the plan with the primary care team.

Clinical pharmacists are also included as integrated team members in [CMMI’s Making Care Primary \(MCP\) Model](#) – a 10½-year CMMI multi-payer model with three participation tracks that build on previous primary care models, such as the CPC, CPC+, and Primary Care First models as well as the Maryland Primary Care Program.

ACCP also highlighted the growing importance of pharmacogenomics (PGx) and precision medicine to ensure safe and effective therapy for each patient. When integrated into CMM, PGx testing allows for targeted treatment decisions on the basis of the characteristics of each patient’s unique genetic profile. Integration of PGx within CMM reduces costs, improves outcomes and access to care, and enhances patient and provider quality of life and satisfaction. ACCP Member Spotlight: Elizabeth (“Liz”) Chang



Elizabeth “Liz” Chang, Pharm.D., Ph.D., is chair of the Department of Clinical Pharmacy and an associate professor at Taipei Medical University (TMU) College of Pharmacy in Taiwan. She also serves as deputy director for education in the pharmacy department at

Wanfang Hospital, an affiliated hospital of TMU. Chang earned a B.S. degree in pharmacy from National Taiwan University, then went on to earn her Pharm.D. and M.S. in pharmacy administration degrees from the Ohio State University and a Ph.D. degree in pharmaceutical socio-economics from the University of Iowa. Chang completed an internship at Nationwide Children’s Hospital.

Chang educates students on social and administrative pharmacy topics and coordinates a clinical skills lab and advanced pharmacy practice experiences (APPEs). She serves as a college liaison for international collaboration with U.S. colleges of pharmacy and has coordinated an international clinical faculty training program in collaboration with partners in the United States and Singapore. Committed to education and as deputy director for education, Chang facilitated the development of a pharmacy residency program at Wanfang Hospital and a specialist pharmacist career ladder system for TMU-affiliated hospitals. She strongly believes that pharmacists must practice at the top of their license.

With her specialization in qualitative and mixed methods research, Chang’s recent research projects focus on practice-based issues, including medication adherence, medication reconciliation, and pharmacy education. Other projects include health literacy and cultural competence. An area where Chang envisions practice advancement is the pharmacist’s role in immunizations. In Taiwan, pharmacists currently play no role in vaccine administration but are striving to change that!

Chang did not begin her membership with ACCP until becoming faculty at TMU. After joining, several ACCP Fellows and members became role models in transforming Chang as a pharmacy educator and administrator. In 2021, Chang co-founded the ACCP Taiwan Chapter, which afforded further networking and international partnerships. The collaboration of the ACCP Taiwan Chapter and the ACCP Cardiology PRN is especially meaningful to Chang because it has revealed differences in practice across countries, ultimately advancing current practices in Taiwan. Currently, she serves as secretary/treasurer of the ACCP Taiwan Chapter. Recruitment continues to increase for both the Taiwan Chapter and the ACCP international membership! She attributes her professional growth to connecting with ACCP members and the readily available resources:

My advice to all pharmacists, students, and residents is to reach out to other members of ACCP. You may be surprised with how much you gain just by reaching out! I have truly benefited from the generosity and experience-sharing from other ACCP members.

A startling number of common barriers currently prohibit advanced practice across international sites, which Chang believes can be overcome by simply sharing experiences. In fact, she intentionally integrates advocacy for pharmacists’ value into her roles as educator, pharmacist, and mother. She reminds her student pharmacists of the importance of joining professional societies, volunteering for projects, and staying informed on new practice and reimbursement models. In addition, she teaches the need for community outreach and spreading the word about how pharmacists contribute to medication safety. And finally, Chang teaches that the status quo can change if like-minded individuals collaborate and advocate to expand, advance, and show the importance of the pharmacist’s role as part of the health care team.

2024 ACCP Fellows: Fellowship is awarded in recognition of continued excellence in clinical pharmacy practice or research. Nominees must have been Full Members of ACCP for at least 5 years, must have been

in practice for at least 10 years since receipt of their highest professional pharmacy degree, and must have made a sustained contribution to ACCP through activities such as presentation at College meetings; service to ACCP committees, PRNs, chapters, or publications; or election as an officer. Candidates must be nominated by any two Full Members other than the nominee, by any Fellow, or by any member of the Board of Regents. 2024 Paul F. Parker Medal for Distinguished Service to the Profession of Pharmacy: Recognizes an individual who has made outstanding and sustained contributions to improving or expanding the profession of pharmacy in an area of professional service – including, but not limited to, patient care, leadership, administration, finance, technology, information processing, service delivery, models of care, and advocacy. The award is not limited to pharmacists or ACCP members. Nominations must consist of a letter detailing the nominee's qualifications for this award and his or her contributions to the profession of pharmacy; the nominee's curriculum vitae, resume, or biographical sketch as available; and a minimum of three letters of recommendation. At least one of these letters must be from an individual outside the nominee's current practice locale. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Parker Medal Selection Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2023, including supporting documents.**

Robert M. Elenbaas Service Award: Considered to be a lifetime achievement award, this honor is conferred only when a particularly noteworthy candidate is identified in recognition of outstanding contributions to the vitality of ACCP or to the advancement of its goals that are well above and beyond the usual devotion of resources, be it time, energy, material goods, or a combination thereof. It is expected that nominees for this award will have been serving the mission of ACCP/clinical pharmacy for at least 20 years at the time of nomination. Nominations will consist of a letter from an ACCP member detailing the nominee's qualifications for the award and his or her contributions to the College, the nominee's curriculum

vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, or ACCP staff are ineligible. **Nomination deadline: November 30, 2023. Supporting documents are due February 1, 2024, as noted above.**

C. Edwin Webb Professional Advocacy Award: Like the Elenbaas Award above, this is considered to be a lifetime achievement award. The Webb Award is given only when a particularly noteworthy candidate is identified who has made outstanding contributions to the visibility and value of clinical pharmacy in national policy, intraprofessional, and interprofessional arenas; has assembled a record of mentoring others who have gone on to assume a health professions and health policy leadership role; and is recognized as an ambassador for clinical pharmacy both within and outside the profession. It is expected that nominees for this award will have advocated for the mission of ACCP/clinical pharmacy for at least 20 years at the time of nomination. Nominations will consist of a letter from an ACCP member detailing the nominee's qualifications for this award and his or her contributions to the College, the nominee's curriculum vitae, and a minimum of two letters of recommendation from either ACCP or non-ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice/place of employment. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, or ACCP staff are ineligible. **Nomination deadline: November 30, 2023. Supporting documents are due February 1, 2024, as noted above.**

2025 Therapeutic Frontiers Lecture Award: Honors an internationally recognized scientist whose research is actively advancing the frontiers of pharmacotherapy. The recipient of this award is not required to be an ACCP member. Nominations must include a letter of nomination from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her sustained contributions to pharmacotherapy, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors,

Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2022. Supporting documents are due April 1, 2024, as noted above.**

2024 Russell R. Miller Award: Recognizes an ACCP member who has made outstanding contributions to the professional literature of clinical pharmacy, either as a single, landmark contribution or by sustained excellence over time. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her contributions to the professional literature, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: November 30, 2023. 2024 Clinical Practice Award: Recognizes an ACCP member who has developed an innovative clinical pharmacy service, provided innovative documentation of the impact of clinical pharmacy services, provided leadership in developing cost-effective clinical pharmacy services, or shown sustained excellence in providing clinical pharmacy services. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her contributions to clinical pharmacy practice, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. 2024 Education Award: Recognizes an ACCP member who has demonstrated excellence in the classroom or clinical training site, conducted innovative research in clinical pharmacy education, demonstrated exceptional dedication to continuing education programs, or demonstrated leadership in the development of education programs. Nominations will consist of a letter from an ACCP member to the

2024 New Investigator Award: This award highlights the research program of an ACCP member who has made a major impact on an aspect of clinical pharmaceutical science. Nominees must have been a Full Member of ACCP at the time of nomination and a member at any level for at least 3 years; they must have a research program with a significant publication record having a programmatic theme or an especially noteworthy single publication; and it must have been within 6 years since completion of their terminal professional pharmacy training or degree, whichever is most recent. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her research program, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2024. Supporting documents are due April 1, 2024, as noted above.**

2024 New Clinical Practitioner Award: This award recognizes a new clinical practitioner who has made outstanding contributions to the health of patients and/or the practice of clinical pharmacy. Nominees must have been Full Members of ACCP at the time of nomination and members at any level for at least 3 years. In addition, nominees must have completed their terminal professional pharmacy training or

degree (whichever is most recent) within 6 years from the time of selection by the Board of Regents. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Fellows of ACCP (i.e., "FCCPs") are ineligible. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her clinical contributions, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2024. Supporting documents are due April 1, 2024, as noted above.**

2024 New Educator Award: This award recognizes and honors a new educator for outstanding contributions to the discipline of teaching and to the education of health care practitioners. Nominees must have been Full Members of ACCP at the time of nomination and members at any level for at least 3 years. In addition, nominees must have completed their terminal professional pharmacy training or degree (whichever is most recent) within 6 years from the time of selection by the Board of Regents. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Fellows of ACCP (i.e., "FCCPs") are ineligible. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her clinical contributions, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2024. 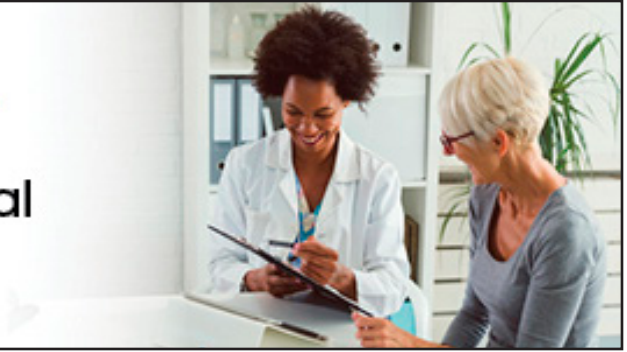
